

MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held June 21, 1983 in Council Chambers with all members present except Mr. Harper.

Members of the press: Dick Mangrum - WSNW Radio, Sharon Lucas - Anderson Independent & Glen Gannaway - Seneca Journal.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Dr. Earle.

Mr. Butts made a motion, seconded by Dr. Earle, approved 4 - 0 (Mr. Harper absent) to adopt the minutes of the June 7, 1983 meeting as printed.

Dr. Earle made a motion, seconded by Mr. Brandt, approved 4 - 0 (Mr. Harper absent) to accept the bid for the same coverage as we presently have of Blue Cross/Blue Shield for health insurance for the coming fiscal year and to make up the difference in the cost budgeted and the actual cost from contingency. The cost will be approximately \$6200.

Next on the agenda Mr. E. O. Ferrell, Mr. Jim Hendricks, & Mr. Wilson Owen of Duke Power addressed Council on the possibility of Oconee County withdrawing water from Lake Keowee if the need should ever arise. Mr. Hendricks assured the Soil & Water Conservation Commission Members that even though generation of electricity was the first priority Oconee County would not be cut off if an emergency need of water ever arose.

Mr. Tom B. Anderson requested maintenance of a road in Chauga Valley Subdivision. Mr. Crain referred this to the Roads & Transportation Committee and asked them to make a decision within thirty days.

Mr. Butts made a motion, seconded by Dr. Earle, approved 4 - 0 (Mr. Harper absent) that Oconee County accept a \$30,000 state grant already approved by the state and a matching ARC Grant for \$30,000 if approved to install a sewer line on Hwy. 123.



Mr. Brandt made a motion, seconded by Dr. Earle, approved 4 - 0 (Mr. Harper absent) to adopt Ordinance 83-6, "An Ordinance to Establish the Anderson-Oconee Alcohol & Drug Abuse Commission & Repeal Ordinance 79-10.

Mr. Williams made a motion, seconded by Dr. Earle, approved 4 - 0 (Mr. Harper absent) that the attached transfers (monies already in budget) be approved.
