

MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held November 6, 1984 at 7:00 PM in Council Chambers with all members present.

The invocation was given by Mr. Williams.

Mr. Butts made a motion, seconded by Dr. Earle, approved 5 - 0 that the minutes of the October 16, 1984 meeting be adopted as printed.

Minutes

Mrs. Alice V. Slone, representing the homeowners on the west side of Cherokee Lake addressed Council concerning maintenance on County Roadway CH 9. The homeowners asked that the roadway be paved because of the dust of the dirt roadway, but after considerable discussion it was determined the roadway should wait its turn on the priority list.

Dr. Earle made a motion, seconded by Mr. Brandt, approved 5 - 0 that Oconee County accept Smith Data's proposal for the hardware, software, ribbons, diskettes, etc. for the Tax Center at \$133,473.28 and their offer to let Oconee County use their Administrative Program on a six months free trial offer according to the terms of their proposal providing installation be no later than December.

Mr. A. W. Smith of Smith Data said they hoped to start moving some of the equipment in on Friday, November 9, 1984 or the following week.

Dr. Earle made a motion, seconded by Mr. Williams, approved 3 - 1, (Mr. Brandt voting against, Mr. Butts absent) that Ordinance 84-2, "An Ordinance To Provide For Regulation Of Activities In The Public Parks And Recreation Areas In The Unincorporated Portions Of the County" be adopted on second reading.

Dr. Earle made a motion, seconded by Mr. Williams, that Ordinance 84-8, "An Ordinance To Regulate The Franchising Of The Playing Of The Game Of Bingo In Oconee County, And To Provide For Penalties For Violation Of This Ordinance" be adopted on first reading.

Mr. Brandt made a motion, seconded by Mr. Harper, approved 4 - 0 (Mr. Butts absent) to amend the word may to shall in Section III, Line III of Ordinance 84-8.

Ordinance 84-8, as amended was adopted 4 - 0 (Mr. Butts absent).

Dr. Earle reported that the Personnel & Intergovernmental Committee had met with the Clemson History Department at Lunney Museum November 5, 1984 and they are going to make a proposal concern- the operation of the museum.

Dr. Earle made a motion, seconded by Mr. Brandt, approved 4 - 0 (Mr. Butts absent) that Oconee County no longer pay Tort insurance on the Commission Members of the Tribble Center and they be so notified by mail.

Dr. Earle made a motion, seconded by Mr. Brandt, approved 4 - 0 (Mr. Butts absent) to invite the management of Cablevision to the next Council Meeting as some of the Council Members has been receiving complaints about their service.

Mr. Harper made a motion, seconded by Dr. Earle, approved 4 - 0 (Mr. Butts absent) that the attached Arts Contract be adopted.

Dr. Earle made a motion, seconded by Mr. Williams, approved 4 - 0 (Mr. Butts absent) that the Clerk hired for the Tax Collector's Office be allowed to continue her present salary of \$8,407 instead of being lowered to the \$8,156 entry level for that position as she is transferring from one county office to another.


