**Call to Order:**

Mr. Dexter called the meeting to order at 7:00 p.m.

**Executive Session:**

Mr. McCall made a motion, seconded by Mr. Thrift, approved 4 – 0 to enter into Executive Session for the purpose of receiving legal advice regarding legal action related to an ongoing matter. Council entered Executive Session at 7:01 p.m.

Mr. McCall made a motion, seconded by Mr. Thrift, approved 4 – 0 to return from Executive Session at 7:48 p.m. Mr. Dexter noted that no actions were taken in Executive Session.

Mr. Corbeil made a motion, seconded by Mr. Thrift, approved 4 - 0 to approve on first and final reading Resolution R2010-03 “A RESOLUTION MAKING APPLICATION TO THE STATE BUDGET AND CONTROL BOARD OF SOUTH CAROLINA FOR APPROVAL OF THE ISSUANCE BY OCONEE COUNTY, SOUTH CAROLINA, OF ITS SPECIAL SOURCE REVENUE BONDS IN AN AGGREGATE PRINCIPAL AMOUNT OF NOT EXCEEDING \$5,500,000, PURSUANT TO THE PROVISIONS OF SOUTH CAROLINA CODE ANNOTATED, TITLE 4, CHAPTER 1 AND 29 (1976), AS AMENDED” to submit an application to the South Carolina Budget & Control Board to approve up to \$5.5 million dollars in special source revenue bonds as previously discussed and to authorize payment of the application fee from council contingency to be reimbursed from the bond proceeds.
