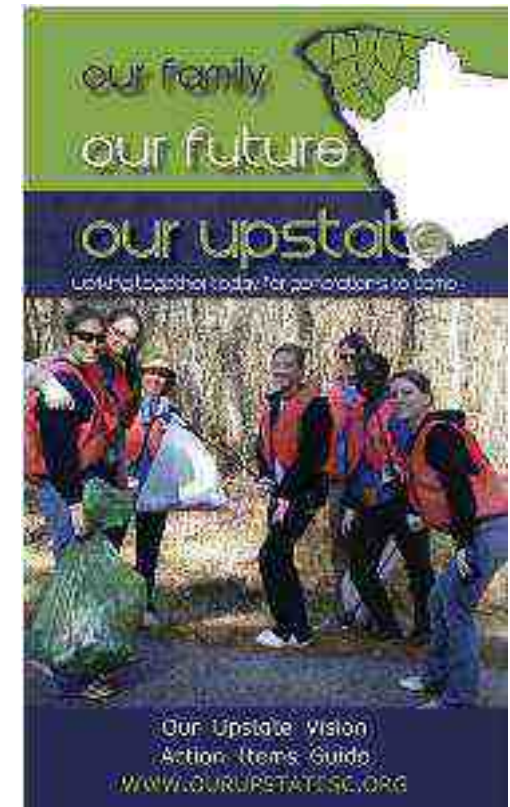

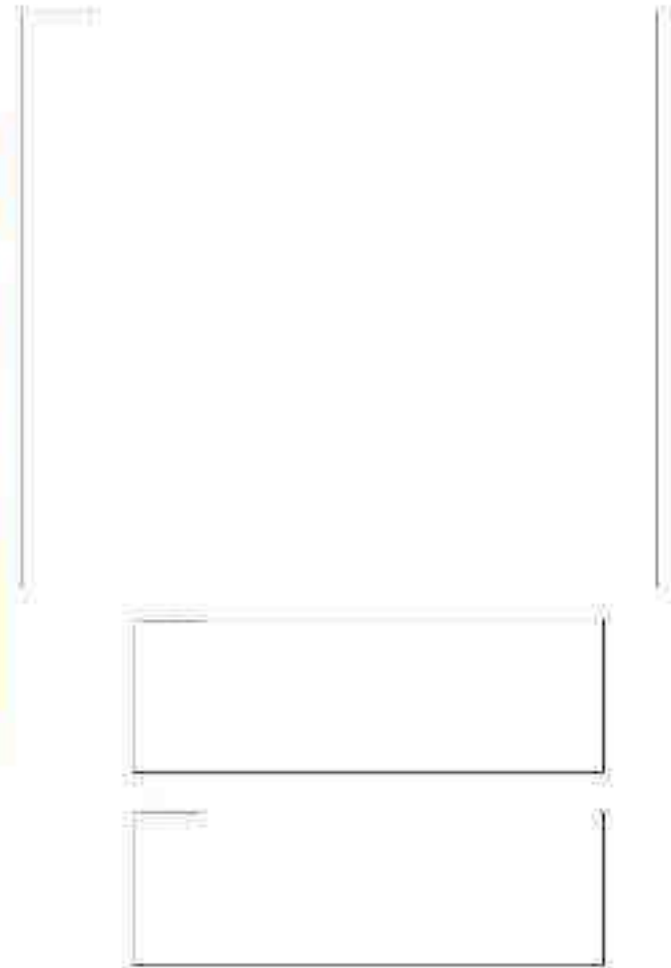

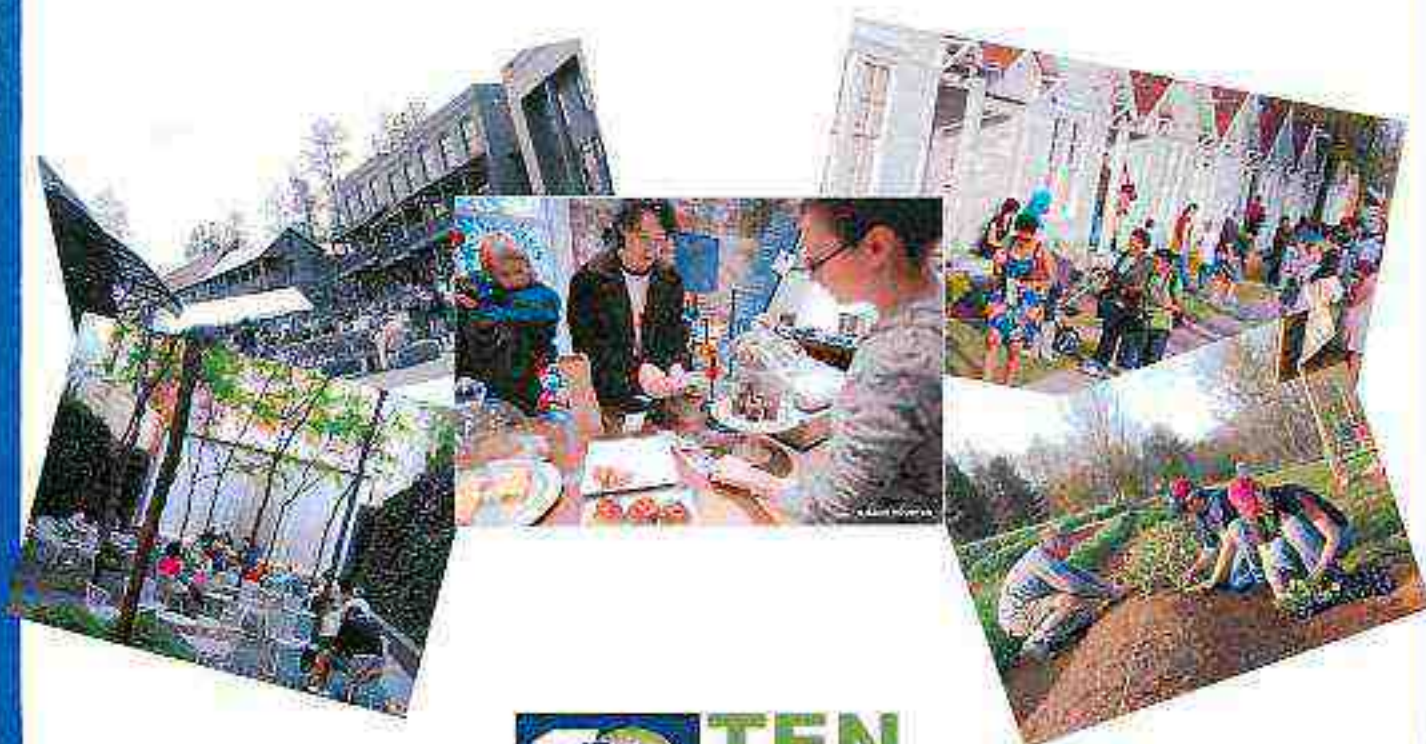

Ten at the Top Programs & Initiatives – April 2013

Objective: Build trust among leaders and residents across the ten counties of the Upstate.

- Engaged more than 10,000 Upstate residents in year-long effort to develop a Shared Upstate Growth Vision.
- Partnered with six other regional organizations to develop regular meetings of Upstate city, county and state elected officials to discuss key issues facing the region.
- Created the Our Upstate Vision Regional Forum Series, which includes quarterly regional forums each focused on a key issue that impacts current and future growth in the region.
- Developed the Upstate Information Hub (www.ourupstatesc.info) that includes a regional calendar and links to more than a thousand resources available across the region.
- Commissioned a survey to develop baseline understanding of how business and community leaders view collaboration across the Upstate.

Objective: Articulate and promote a regional vision and strategy that protects and enhances the economic vitality, natural and cultural resources and assets, and quality of life within the region.

- Developed regional task forces in each of the five regional vision driver areas.
- Partnered with the Clemson University graduate program in planning to develop the Regional Vision Tool Kit.
- Partnered with USC Upstate Urban Planning & Policy classes to develop list of “great idea” of communities across the state and country that have increased vibrancy in their community around the areas of neighborhoods, downtowns, parks & recreation, events & programs and arts & culture. Will be hosting four workshops across the region in May where local leaders will have an opportunity to speak first hand with leaders from some of the “great idea” communities.
- Facilitating and coordinating the Upstate Air Quality Advisory Committee and Clean Air Upstate initiative to reduce emissions and stay within federal air quality standards.
- Developed framework to create an Entrepreneurial Friendly Community program in the Upstate. Initiative is currently being developed by the Appalachian Council of Governments.

Objective: Initiate, convene and facilitate activities that articulate the value of and foster the development of regional collaboration, coordination and cooperation.

- Currently convening regular meetings of water system directors across the Upstate. Group developed a unified message that was sent to SC DHEC and DNR regarding the South Carolina surface water assessment.
- Brought together public and private planners from across the region to create the Upstate Professional Planners Group. The group meets three times annually to discuss opportunities for regional collaboration and to support economic development and sustainable growth in the region.
- Helped facilitate development of a regional Memorandum of Understanding (MOU) between GPATS (Greenville Pickens Area Transportation Study), SPATS (Spartanburg Area Transportation Study) and ACOG (Appalachian Council of Governments) that allows these transportation organizations to partner on initiatives, grants and projects. Since the approval of the MOU, the organizations have partnered on the SMART Upstate transportation mapping program. They are also working together on traffic signal coordination.
- Worked with the seven United Ways from across the Upstate to create a partnership to move forward with a regional messaging program around the importance of early childhood education called the Born Learning Program.
- As follow-up to feedback from a recent regional forum, Ten at the Top is convening representatives from Workforce Organizations, Education and Business/Economic Development to create a regional coalition designed to enhance cross-sector communications regarding the issue of Workforce and Skill Development.
- Following a regional forum in September 2012 on Senior Issues, TATT has convened three meetings of interested stakeholders to identify regional opportunities to support key issues facing seniors today and into the future.

How South Carolina's Upstate Benefits When You Support Ten at the Top

Altruistic Value: Your support of TATT helps the Upstate by ensuring the region has an organization that:

- Focuses every day on regional collaboration and how we can work together across communities and sectors to ensure the Upstate is addressing key issues regarding quality of life and long-term growth from a strategic regional standpoint.
- Is connecting key leaders from a wide range of stakeholder groups across the region so they can discuss issues of regional significance and explore what opportunities for regional collaboration and maximizing resources exists within that particular issue.
- Is building a regional framework where identifying potential partners and opportunities for collaboration beyond city, county or sector boundaries is no longer an add-on conversation at the end of a process, but instead part of the strategy and discussions from the very beginning.
- Is building trust and partnerships amongst business and community leaders throughout the Upstate so that when there is a major regional issue, crisis or opportunity the Upstate will be ready to react immediately instead of having to spend time growing relationships and trust.

Regional Outreach: Your support of TATT helps ensure that issues of significance to residents across the region are understood and addressed within the regional context:

- TATT engaged more than 10,000 Upstate residents in a year-long conversation on "What Matters Most" across the Upstate. This led to the creation of the Our Upstate Vision and the focus of TATT projects and initiatives around five regional drivers: Human Potential, Economic & Entrepreneurial Vitality, Sustainable Growth, Natural Beauty & Resources and Community Vibrancy.
- Continuing the effort to encourage dialogue and planning on issues related to how we are growing as a region, TATT created the Our Upstate Regional Forum Series, which is a quarterly series of forums focused on issues facing the Upstate both today and as we look toward the future. These forums are held in different locations across the region and each forum centers on a different topic related to how we are growing and planning for the future.

Specific Meetings and Collaborative Efforts: Your support of TATT helps build regional dialogue and partnerships:

- Over the last several months, Ten at the Top has convened, facilitated or coordinated meetings of several different groups from across the region. Below is an overview of the current results following those meetings:
 - **Upstate Air Quality Advisory Committee** – In 2012 TATT was asked to become the convener and coordinator of this regional effort to ensure that the Upstate remains within compliance of federal EPA standards for air emissions. This is both a public health and an economic development issue and the Upstate Air Quality Advisory Committee includes representatives from a wide variety of stakeholder groups. The committee has developed a regional Education & Outreach Program (called Clean Air Upstate) that includes a public campaign that will launch later in 2013. It also includes a regional pledge/resolution that has been approved by three counties as well as more than a dozen businesses and organizations across the Upstate. The committee also has developed a list of strategies that can be implemented by individuals, businesses and institutions as well as city and county governments to help reduce emission levels.
 - **Upstate United Way Directors: Born Learning Messaging Campaign** – The directors of the seven United Ways in the Upstate came together in mid-August of 2012 to discuss potential regional collaboration around the subject of the value of education in the Upstate. Education is a United Way focus area and all the local organizations are engaging in some efforts around the issue. The group has formed a partnership to move forward with a regional message program around the importance of early childhood education called the Born Learning Program. The regional messaging campaign will kickoff in July 2013 and marks the first time all seven United Ways in the Upstate have ever partnered on a regional initiative.
 - **Connecting Workforce Organizations, Education Organizations and Business/Economic Development** – A regional forum on Workforce & Skill Development hosted by TATT in January 2013 identified the need for communication and collaboration amongst workforce groups, educators and business/economic development on the issue of workforce & skill development. While there are many workforce initiatives currently underway or being created, the general consensus is that they are being created within silos (either stakeholder groups or geographically) with little cross-communication. TATT is currently working to convene a meeting of representatives from all three stakeholder areas to discuss the possibility of creating a regional workforce & skill development coalition that would not create new initiatives, but would instead encourage communication and the creation of regional partnerships when appropriate.

- **Upstate Water & Sewer Directors** – TATT has facilitated three meetings of Upstate water and sewer system directors to discuss possible collaboration opportunities. The group recently developed a unified regional message that was sent to South Carolina DHEC and DNR in response to current state ground water assessment efforts.
- **Upstate Professional Planners** – The Sustainable Growth Task Force identified bringing together public and private planners from across the region as an important regional action. The initial meeting was held in May of 2012 and has led to the development of the Upstate Planners Group, which meets three times annually to discuss collaboration amongst planners across the region. TATT also helped the Upstate Planners develop an on-line platform for on-going dialogue and discussion.
- **Transportation Planning Organizations** – In 2011, TATT helped facilitate the development of a regional Memorandum of Understanding (MOU) between GPATS (Greenville Pickens Area Transportation Study), SPATS (Spartanburg Area Transportation Study) and ACOG (Appalachian Council of Governments). The agreement was approved by the governing bodies of each group in January 2012 and marks the first formal regional planning agreement in the Upstate. Since the approval of the MOU, the organizations have partnered on the SMART Upstate transportation mapping program. They are also working together on traffic signal coordination.
- **Upstate Tourism Directors** – TATT hosted a meeting of tourism directors in the region in January of 2012 and discussions are on-going regarding potential collaboration efforts in the area of promoting tourism events and activities across the Upstate.
- Ten at the Top task forces have also held meetings of interested residents and leaders across the region on specific topics including:
 - Access to Preventive Health Care
 - Increasing the number of Upstate residents with post-secondary degrees
 - Senior Issues
- In 2010, Ten at the Top partnered with the Upstate SC Alliance, Upstate Chamber Coalition, Upstate Forever and the three Councils of Governments in the region to host the first Upstate Elected Officials meeting of city, county and state leaders from across the Upstate. These regular meetings have continued with each one focused on a specific topic or issue. To date, six Upstate Elected Officials Meetings have been held with an average attendance of more than 100 elected and business leaders from across the Upstate. The next meeting is scheduled for April 4th.

Regional Initiatives: *Your support of TATT helps support development and implementation of regional programs including:*

- **Upstate Information Hub:** The Upstate Information Hub (www.ourupstatesc.info) is a comprehensive regional web portal created to serve as a central location on the internet where people can find information and resources available across the region. The Information Hub currently includes more than 1,200 links to resources across the Upstate. The regional calendar includes nearly 300 events and programs happening across the region.
- **Regional Planning Tool Kit:** The Regional Planning Tool Kit was developed in 2012 to serve as a resource for city and county planners and planning commissions as they make future land use decisions. It includes an overview of planning resources in South Carolina as well as examples of how planning tools are being used in communities across the country. The tool kit is available electronically and is being included in the continuing education workshop that is required for all city and county planning council members.
- **Community Vibrancy Great Ideas:** In partnership with Urban Planning & Policy Classes at USC-Upstate, TATT is identifying local and national “great ideas” in how communities are creating community vibrancy around neighborhoods, downtowns, events & programs, cultural activities and parks & recreation. The completed list will be released in May as part of a series of regional workshops on Community Vibrancy that are being held May 22-23 at locations across the region.
- **Entrepreneurial Friendly Community Designation Program:** The Economic & Entrepreneurial Vitality Task Force spent several months to develop a region-wide Entrepreneurial Friendly Community Designation Program based on a number of other programs that exist across the country. The Appalachian Council of Governments is currently identifying the best way for this program to be structured and promoted across the Upstate.
