

MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular Oconee County Council Meeting was held July 20, 1982 at 3:00 P.M. in Council Chambers with Mr. Brandt, Mr. Butts & Dr. Earle present.

Members of the press present: Dick Mangrum - WSNW Radio, Cobb Oxford - Seneca Journal, Dick Givens - Greenville News, Ashton Hester - Keowee Courier & Sharon Lucas - Anderson Independent.

The invocation was given by Mr. Butts.

Mr. Brandt made a motion, seconded by Mr. Butts, approved 3 - 0 (Mr. Williams & Mr. Harper absent) to adopt the minutes of the July 6, 1982 meeting.

Mr. Medford explained to Council the procedure of soil classification. Basically the Assessor's Office takes a 1" - 25' soil map and blows it up to fit the 1" - 400' tax map and marks the different types of soil on the tax map. The soil classification determines the value of the property and so far Oconee County has six different types of soil. From the soil classifications it looks as if the agricultural land value will be lower this year than last year.

Mr. Butts presented Ordinance 82-6, "Acceptance of Roads in Subdivisions" as amended adding Section 2B & C and Section 3B and made a motion it be adopted on third and final reading as amended. This motion was seconded by Dr. Earle, approved 3 - 0 (Mr. Williams & Mr. Harper absent).

Mr. Butts presented Ordinance 82-7, "Acceptance of Roads not in Subdivisions" and made a motion it be adopted as printed on second reading. This motion was seconded by Mr. Brandt, approved 3 - 0 (Mr. Williams & Mr. Harper absent).

Dr. Earle presented Ordinance 82-8, "Establishing Fees for Landfills" and made a motion it be adopted on second reading. This motion was seconded by Mr. Butts, approved 3 - 0 (Mr. Williams & Mr. Harper absent).

Mr. Butts made a motion that the County abide by Ordinance 82-8 until third and final reading. This motion was seconded by Dr. Earle, approved 3 - 0 (Mr. Williams & Mr. Harper absent).

Dr. Earle presented Ordinance 82-9, "Industrial



Revenue Bonds for Torrington Mfg. Co." and made a motion this Ordinance be adopted on second reading. This motion was seconded by Mr. Brandt, approved 3 - 0 (Mr. Williams & Mr. Harper absent).

Mr. Brandt made a motion that the County accept a bid from Hartford Insurance Co. for \$1,014.60 for insurance for the volunteer fireman. This policy includes a \$10,000 accidental death clause. This motion was seconded by Dr. Earle, approved 3 - 0 (Mr. Williams & Mr. Harper absent).

Ms. Lucy Murr of the Probation Office expressed her appreciation to Council for their new offices, also a special thanks to Mr. Frank Harvey & Mr. Clayton Stancil for helping them get moved into their new offices. She also invited the Council Members to come and see the new offices.
