Mr. Butts made a motion, seconded by Mr. Dyar, approved 4 - 0 (Dr. Earle absent) that Resolutions 85-2, 85-3 and 85-4 recognizing Mr. Roy D. Harden, Mr. John W. Fowler & Mr. Larry C. Brandt for their services to the county be adopted.
