MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held Tuesday, June 19, 1990 at 3:00 PM in Council Chambers with all Council Members and the County Attorney present.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media. Call to Order:

The invocation was given by Mr. Dyar. Invocation

Dr. Earle made a motion, seconded by Mr. Stone, approved 5 - 0 that the minutes of the June 5, 1990 meeting be adopted as printed. Minutes

Mr. Johnny McLellan, Chairman of the Finance Committee of the Sewer Commission presented Council with the attached amended 1990-91 Sewer Commission Budget. Item number 51 - Depreciation Fund in the amount of \$407,166 is the amendment in the budget. After discussion, in which Mr. McLellan informed Council that all industries in the county will be affected and the rates to the towns will increase from \$1.04 to \$1.33 per thousand gallons of flow, Dr. Earle made a motion, seconded by Mr. Harper, approved 5 - 0 that the amended budget be adopted. Sewer Budget

At the request of Mrs. Becky Gerrard, Chief Magistrate and Mr. Larry Butts, Seneca Magistrate, Mr. Strickland made a motion, seconded by Mr. Stone approved 5 - 0 that the Seneca Magistrate's Office be relocated to Adams Plaza and that \$960 be transferred from in county travel into building maintenance to cut a window in the secretary's office and to put down carpet. The rent will be the same per month and the first month's rent will be the cost of the renovations to the building. Relocation of Seneca Magistrate's Office

Mr. Strickland made a motion, seconded by Dr. Earle, approved 5 - 0 that the attached transfer for Rural Fire be approved. Rural Fire (Transfer)

Mr. Stone made a motion, seconded by Dr. Earle, approved 5 - 0 that the attached transfer for Motor Pool be approved. Motor Pool (Transfer)

Mr. Strickland made a motion, seconded by Mr. Stone, approved 5 - 0 that the attached transfer for the Law Enforcement Center be approved. LEC (Transfer)

Mr. Stone made a motion, seconded by Mr. Strickland, approved 5 - 0 that \$3,500 be taken from contingency and placed in line item 10 074 00150 00850 to construct a storage building for lawn mowers and equipment. These items have previously been stored in the same area as the radio equipment.

Dr. Earle made a motion, seconded by Mr. Stone, approved 5 - 0 that the attached transfer for PRT be approved.

Mr. Harper made a motion, seconded by Mr. Dyar, approved 5 - 0 that the attached right of way agreement between Oconee County and Cross Creek Development Company for right of way through Cross Creek Subdivision for installation and maintenance of sewer lines be adopted.

Dr. Earle made a motion, seconded by Mr. Stone, approved 5 - 0 that the attached contract to refurbish the existing beacon light at the airport be adopted. This contract is in the amount of up to \$1,000 - 90% federal funding, 5% state funding and 5% local funding; however the local county match be approximately \$750.00.

Mr. Dyar made a motion, seconded by Mr. Stone, approved 5 - 0 that Gary Concrete be awarded the bid for two bridge decks, barriers, caps and hardware at a cost of \$43,671.60. (See attached bid)

Bridge Decks

Mrs. Marianne Dillard, Purchasing Director informed Council the bid for the drag line for the Rock Crusher came in above funds allotted for this project. Mr. Crumpton, Rock Crusher Director, asked that this be put out for bids again or the funds carried over into the 1990-91 budget.

Drag Line

Mr. Barry Nickles addressed Council regarding the 1990-91 Oconee County budget. Mr. Nickles expressed concern that 72% of the budget was for the school system, he stated that something should be substantiated regarding school spending. Mr. Nickles also expressed concern about the county being in debt if the school should sell bonds and bonds should be sold for upgrading of the hospital system.

Dr. Earle made a motion, seconded by Mr. Dyar, that Ordinance 90-6, "1990-91 Oconee County Budget Ordinance" as amended be adopted on third reading.

The budget as amended was then adopted 3 - 2 (Mr. Strickland and Mr. Stone voting against).

Mr. Dyar made a motion, seconded by Mr. Strickland, approved 5 - 0 that Ordinance 90-7, "Oconee County Building Codes Ordinance" be adopted on second reading with effective date being July 1, 1991.

Mr. Stone made a motion, seconded by Dr. Earle, approved 5 - 0 that \$350 be taken from contingency and placed in line item 10 028 00150 00068 for advertisements of county positions.

After considerable discussion regarding the water problem of property owners adjacent to the Law Enforcement Center, Mr. Dyar made a motion, seconded by Dr. Earle, approved 5 - 0 that the Supervisor or his designee go down and look at the problem at the Law Enforcement Center and determine the cost of constructing a crossover large enough to handle heavy equipment on Mr. C.L. Walling's property so he can get from one side of his property to the other.

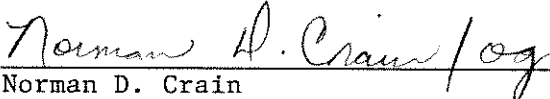
