Discussion Regarding Action Items

Engineering Services for Coneross Farm Road [not to exceed \$90,690]and Alberts Road [not to exceed \$64,240] / total not to exceed \$154,930

At the March 20, 2012 meeting, Council approved the award of RFP 11-15 for On Call Engineering Services to Davis & Floyd, Inc., of Greenwood, SC for Category C: On Call Roadway & Bridge Services. The Roads & Bridges Department wishes to contract with Davis & Floyd to provide engineering services for the construction and paving of Coneross Farm Rd (WA-149) and the replacement of an existing bridge on Alberts Rd (WA-71): Coneross Farm Rd is a gravel road approximately 2,300' in length. The bridge on Alberts Rd is a single-lane bridge. Davis & Floyd will provide services such as: topographic surveys, hydraulic studies and recommendations, layout plans and construction drawings, submitting all required permitting, centerline offset staking, route survey, and construction administration with site visits.

It is the staff's recommendation that Council approve the total award of \$154,930.00 to Davis & Floyd, Inc., of Greenwood, SC for engineering services for the above mentioned projects.
