February 6, 1975

Mr. Bailes opened the meeting at 8:00 P.M.

Buddy Herring said the prayer.

Mr. Phillips and Mr. Little of Jones and Fellers Architectural Firm discussed with Council plans and funding for the new jail. They hope to have figures on a solid, adequate building that will serve the purpose within about 3 weeks.

Mr. Moore also looked into the heat and air conditioning for the Court House. This was also requested by the insurance companies. This was taken care of locally, at a much cheaper rate than the insurance man quoted himself.

Minutes of the last meeting were approved as published.

Mr. Ramey proposed the following recommendations:

Recommendation #1:

- 1. That the Council go on record to support the issuance of Bonds necessary to complete the following projects:
 - A) Walhalla Junior High School and the purchase of equipment therefor:
 - B) Completion of additions to Vocational Center, with equipment;
 - C) Expansion of Seneca Junior High School lunch room;

To accomplish the completion of these projects, the following methods of funding will be used if feasible:

- a) "Public Facilities Program" -- possible use to enlarge Seneca Junior High Cafeteria;
- b) Request state aid as to Vocational Center additions;
- c) Necessary borrowing to complete all projects, in any evert.

Mr. Ramey moved this recommendation be adopted as read, seconded by Mr. Thomas. No discussion.

Recommendation #2:

That the Council go on record as being supporative of a capitol improvement program for the school system. That funds be committed to no specific building or area until the presentation by the Oconee County School Board of a "Master Plan."

Mr. Ramey moved for adoption of this recommendation. Seconded by Mr. Moore, No discussion.

Mr. Fedder explained the selling of school bonds and gave some specific amounts. (Through May.)
