Mr. Butts made a motion, seconded by Mr. Dyar, approved 4-0 (Dr. Earle absent) that the minutes of the January 15, 1985 meeting be adopted as printed.

Mr. Williams made a motion, seconded by Mr. Dyar, approved 4-0 (Dr. Earle absent) that Emergency Preparedness be allowed to purchase a four wheel truck 0\$13,672.20 which is state bid price. This money is in the budget and involves no new funds.
