**TITLE: "AN ORDINANCE ADOPTING A REAPPORTIONMENT PLAN FOR OCONEE COUNTY COUNCIL, SINGLE-MEMBER DISTRICTS AND REPEALING OCONEE COUNTY ORDINANCE 91-11"**

**PREAMBLE:**

WHEREAS, SC Code Ann., Section 49-9-90 (1986), requires that single-member election districts for County Council Members be reapportioned as to population by the County Council within a reasonable time prior to the next scheduled general election which follows the adoption by the State of South Carolina of each federal decennial census; and

WHEREAS, the State of South Carolina has now adopted the federal decennial census conducted for the Year 2000 showing Oconee County, South Carolina to have a total population of 66,329 persons; and

WHEREAS, the next scheduled general election following the adoption of the 2000 census is to be held in November, 2002; and

WHEREAS, the Oconee County Council desires to reapportion each of its five (5) single-member Council Districts based upon the 2000 census as required.

NOW THEREFORE, the Oconee County Council in session duly assembled, declares and ordains as third and final reading the following reapportionment plan for Oconee County Council.

**SECTION I:**  
**NUMBER OF DISTRICTS**

Oconee County, South Carolina, shall be divided into five (5) single-member election districts for County Council Member(s).

**SECTION II:**  
**DESCRIPTION OF THE SINGLE-MEMBER COUNCIL DISTRICTS**

The five (5) single-member County Council Districts shall hereafter be delineated as follows:

- (A) County Council District Number One (1) shall contain a total population of 13,424 persons and shall consist of the Voter Precincts and Voter Tabulations as follows:

REDISTRICTING 2000 OCONEE COUNTY  
Public Hearing January 15, 2002

The following comments are based on information in the U. S. Federal Register, January 18, 2001, Vol. 66, No. 12, and S. C. 2000 Code of Laws Title 4, Chapter 9, County Government.

1. South Carolina is one of the states required by the U. S. Department of Justice to have Sec. 5 pre-approval for redistricting. Regarding this pre-approval, the only map available to the public on the proposed redistricting ordinance is a 1973 county map with district lines hand drawn. The boundary lines are unclear.

No verifiable map with Sec.5 pre-approval comparing old district lines with proposed redistricting lines has been available to the public prior to this hearing. I ask that this hearing being postponed for that reason.

2. The U. S. Department of Justice, Civil Rights Division has criteria for redistricting that prohibits splitting a minority-language vote. Based on Oconee County's benchmark map on file with the Department of Justice, the proposed redistricting plan appears to split a Walhalla precinct and thus, splits Walhalla's minority-language Spanish-speaking vote.

Existing Walhalla precincts should not be split and the redistricting as proposed is unacceptable for that reason.

3. Criteria for redistricting are available from the state office of Budget and Statistics. A copy of these criteria is attached. Except to avoid retrogression, the redistricting jurisdiction is required to make the least change to existing district boundaries, follow county, city, or precinct boundaries, protect incumbents, preserve partisan balance, or in some cases, require a certain level of compactness of district boundaries.

The proposed redistricting map does not meet most of the required criteria. County Council should take time to consider other options to redistricting lines that incorporate the required redistricting criteria and give partisan groups time to review such a map and make suggestions and comments.

4. Oconee County Planning Commission has proposed for planning purposes a map for Planning Districts where a large portion of the proposed Planning District residents have similar interests.

I request that a new redistricting map be drawn which conforms to required criteria and where the changing redistricting lines more closely follow the boundaries of community interest suggested for planning purposes by the County Planning Commission.



## *Criteria for Developing Plans: Redistricting 2000*

- Adherence to the Constitutional Requirement of one person, one vote (ie: mathematically equal districts)
  - County Councils must adhere to state law of population variance under 10%
- Adherence to the 1965 Voting Rights Act as amended
- Ensure that parts of districts are contiguous
- Respect Communities of Interest
- Attempt to maintain constituent consistency
- Avoid splitting Voting Precincts
- Solicit Public Input

ORDINANCE 2001-23

**TITLE:** "THE TITLE OF THIS ORDINANCE SHALL BE AN ORDINANCE TO AMEND ORDINANCE 99-15, AN ORDINANCE SETTING FORTH THE SUBSTANCE ABUSE POLICY AND PROCEDURE FOR OCONEE COUNTY."

**WHEREAS,** the above referenced ordinance was adopted November 2, 1999; and

**WHEREAS,** it is the desire of the Oconee County Council to amend Section IX, Types of Testing, Subsection B, Reasonable Suspicion Testing to include the following:

1. Employees may be asked to submit to a drug test if the County has reason to believe that an employee is abusing illegal drugs and/or prescription medications/drugs. Such belief must be based on specific objective facts and reasonable inferences drawn from these facts in light of experience. Reasonable suspicion does not require certainty; however, mere "hunches" are not sufficient to meet this standard. Only a management official will order reasonable suspicion testing.

ORDINANCE NO. 2002-01

AN ORDINANCE CREATING THE

OCONEE COUNTY WATER COMMISSION

BY OCONEE COUNTY COUNCIL, in Session duly assembled, with a quorum present and voting, and upon three readings as indicated below,

BE IT ORDAINED:

**Section 1. Name, Purpose, Effective Date**

This Ordinance shall be known, in addition to its number, as "An Ordinance to Create the Oconee County Water Commission", and shall become effective on

---

The purpose of this Ordinance is to create the Oconee County Water Commission, (hereinafter "Commission") with the duties and authority herein provided.

**Section 2. Authority**

This Ordinance is adopted pursuant to the authority given to the Oconee County Council by South Carolina Code Ann. Section 4-9-39(6) (1986).

**Section 3. Membership**

The membership of the Oconee County Water Commission shall be eleven (11) in number, selected and appointed by a majority vote of the membership of the Oconee County Council voting in Council duly assembled, with one (1) member being selected from each of the five (5) council districts in existence. There shall be one (1) member of this Commission appointed by the Supervisor of Oconee County. The municipalities of Salem, Seneca, Walhalla and Westminster shall each nominate a person to serve on the commission. Pioneer Water District shall nominate a person to serve on the commission.

Should any member of this Commission move and establish residence outside the County district or municipality where such member was residing at the time of the appointment to the Commission, such moving shall constitute a resignation by the member and a replacement shall be appointed to fill the unexpired term of such resigned member.

**Section 4. Term of Members**

Each Member shall serve for a term of four (4) years, with the terms of office, with the terms of office for the initial Members selected from Districts 1, 3, 5, the City of Salem and City of Walhalla to end on December 31, 2004. The terms of office for the remaining Members shall end on December 31, 2006. Thereafter, all members shall serve for a full four (4) year term, or until their successors and officers are duly appointed.

If or in the event any member of the Commission shall fail to attend fifty (50%) percent of the regularly scheduled meetings within a period of twelve (12) calendar months, he/she shall be deemed to have resigned his position and may be replaced without notice by action of Oconee County Council. PROVIDED, HOWEVER, if such absences are excused by the Chairman of the Commission, and/or the Supervisor-Chairman of Oconee County Council, then this provision may be waived.

#### Section 5. Organization, Meetings, Officers

The Oconee County Water Commission shall meet at least once each month, at a time and place selected by the Membership thereto, excepting that upon vote of a majority of its Members, two (2) meetings per year may be suspended and waived.

At the January meeting of each odd-numbered year, there shall be selected a Chairman, a Vice-Chairman and a Secretary, together with such other officers as the Commission may deem necessary, and these officers shall serve for a period of two (2) years or until their successors are duly elected and qualified. Vacancies in any such office by reason of death, resignation or replacement shall be filled for the unexpired term of the officer whose position becomes vacant.

In addition, the Commission may duly adopt such By-Laws as may be necessary for the orderly performance of its duties and functions. Any by-laws which may be adopted by the Commission for the orderly performance of its duties shall comply with the provisions of the general law of the State of South Carolina and this Ordinance, and of all other Ordinances of Oconee County, including, but not limited to, the Freedom of Information Act.

#### Section 6. Powers and Duties

The duties of the Oconee County Water Commission shall be, *inter alia*, as follows:

- a) To collect and study information concerning water issues affecting Oconee County.
- b) To work as a liaison with entities that supply water to the citizens of Oconee County.

- c) To work as a liaison with other Boards and/or Commissions concerning water related issues;
- d) Make recommendations to the Oconee County Supervisor and the Oconee County Council concerning water issues.

The Commission shall submit its advice and counsel in the form of written reports to Council monthly, summarizing the activities, findings and functions of the commission, together with the agenda for the next meeting, all of which shall be in the hands of the Supervisor of the County or his/her designee within a reasonable time. In no event, however, shall this Commission enter into any contracts, contractual obligations, employment of personnel, purchase of equipment or expenditures of funds not itemized and authorized in the budget under which it shall operate, without the prior written consent, affirmation and authorization of Oconee County Council. In any event, the power and authority to enter into any contract binding Oconee County is vested with and shall remain in the Supervisor and Oconee County Council and is not herein delegated to this Commission.

Any advice or recommendations to Oconee County Council may be prepared and presented orally by the Chairman of the Commission at a regularly scheduled meeting of Council after due notice for agenda purposes, or in writing forwarded to the Supervisor-Chairman of the Oconee County Council for dissemination to Council members.

#### Section 7. Salaries and Funding

Each member of the Oconee County Water Commission shall be paid the sum of one hundred (\$100.00) dollars per year, plus expenses for out of County travel, as sole compensation. Any expense item or claim for same shall first be approved by the Chairman of the Commission unless the same is made by the Chairman, and submitted for approval and payment to County Council. In no event shall any Member of the Commission be entitled to any other compensation, direct or indirect, for services on the Commission and such Member shall not provide any services, materials, products, goods or equipment to the County unless the same is sold or offered for sale in accordance with existing County and State purchasing procedures.
