RE: Comments on Public Hearing - Supplemental Budget

*Joint
Statement
for these
issues*

You propose to after-the-event approve implementation of a recently completed staffing study with supplemental funds.

This is an objection to spending supplemental funds at this time for the purpose of implementing new processes. The following reasons are given for my objections:

1. I have heard testimony at Committee meetings that last year's budget is not fully funded and that the difference must be made up in the next annual budget.

Question: Why is this Council beginning non-emergency new expense items before setting aside additional funds for last year's budgeted items?

2. The Staffing Study being implemented fails to take into consideration the fact that Oconee County is transitioning its form of government at the request of the people. I can find no mention that the Supervisor position is being eliminated and that management of County Government will be directed solely by the County Council.

Question: Why did this Council fund \$70,000 for a staffing study that does not consider the possibility of a change in government by referendum which was approved by Council?

3. The Staffing Study notes that it cannot make more than general recommendations for the Planning Department and Airport Operations because these department managers have not kept records and there are no established measurements to determine quality or quantity of the work handled. The study also notes that these managers do not have technical information processing proficiency.

Question: Why does County Management select department heads for promotion to direct entire areas of County government when the selected persons are reported to lack proficiency in management?

Please respond to these questions before voting for an ordinance to use supplement funds to implement a staffing study which does not consider the form of government the County is moving to. You have already allowed implementation of a budget before it has been legally presented to the public - the people who are paying the bill and who are directly affected by your actions.

**OCONEE COUNTY COUNCIL
ORDINANCE 2003-01**

BE IT ORDAINED, by Oconee County Council in Council duly assembled, upon third and final reading:

SECTION I:

This Ordinance shall be known as "THE 2002-2003 SUPPLEMENTAL APPROPRIATIONS ORDINANCE FOR OCONEE COUNTY":

SECTION II:

The purpose of this Ordinance is to amend and modify the 2002-2003 APPROPRIATIONS ORDINANCE FOR OCONEE COUNTY, Ordinance 2002-09 and to make appropriations, both supplemental and primary, from current revenue for the remaining portion of fiscal year 2002-2003 and to transfer funds from department accounts to other authorized uses as stated herein and to implement, approve and ratify the policies and programs authorized by the Oconee County Council, and other matters relating thereto.

Upon establishment of this ordinance, rather than require detailed justifications for each line item, detail will only be required for the following:

- 50084 – School/Seminar/Training/Meeting
- 50840 – Capital Expenditures Equipment (Equipment over \$1,000)
- 50850 – Capital Expenditures Buildings
- 50860 – Capital Expenditures Land
- 50870 – Capital Expenditures Vehicles/Equipment
- 60083 – Grant to Independent Agencies

SECTION III:

The modifications set forth on Exhibit A attached hereto are approved.

SECTION IV:

Unless specifically modified, amended or deleted herein, all appropriations of funds created by the "APPROPRIATIONS ORDINANCE FOR OCONEE COUNTY" (Ordinance 2002-09) are hereby ratified and shall remain in full force and effect as originally adopted. All other sections of Ordinance 2002-09 not modified, directly or by implication shall likewise remain in full force and effect.

Dear Opal and County Council Members,

It is with much sadness in my heart that I write this letter. As I explained to you during our telephone conversation, the Oconee County Chapter American Red Cross desperately needs your help. As of this day, we have a little more than \$1300 in our operating expense account. Several factors have led to this condition, including the current economy and a very disappointing response to our holiday mail solicitation.

We receive approximately 30% of our annual budget from United Way. The next allocation check from United Way will not be issued until April 1st and we will not be able to operate until that time without your help.

We have responded to 11 single-family fires in Oconee County in the past 60 days, which is an average of over 1 fire per week. The American Red Cross is congressionally mandated to provide emergency communication to servicemen on a 24 hour a day, seven day a week basis. There has been an enormous increase in our armed forces emergency service program as our troops begin possible war preparations. This has put an additional strain on our budget as well. We are implementing our "Together We Prepare" program, which is designed to help our community prepare for and deal with the changing levels of threats and by providing brochures to businesses, industries and schools in Oconee County.

We are asking for you to help us be able to help others during these uncertain times. A gift of \$5,000 will help to continue providing services in our community. Your financial support will better enable us to serve the citizens of Oconee County that you represent. Thanks for all you do! If I can be of further service to you in any way, or if you have additional questions, please do not hesitate to call on me.

Oconee A.I.D.'s overall purpose is to provide emergency assistance to Oconee County residents. The A.I.D. office can provide immediate financial assistance and give information and referral to other resources in the county.

Assistance is in the form of payments of a Utility bill, rent, emergency Doctor visit, medication and sometimes a small amount of gas money for medical clinics outside the county. All checks are made to the vendors not the clients. A.I.D. can help a client up to two times in a year, six months apart. The office is open from 9-12 and 1-5 each weekday.

Due to the cold weather, a much higher cost of heating and a 7.6 rate of unemployment we experienced a rise in request for assistance starting in August 2002. We have helped 354 clients since the first of January with a difference of 2,905.58 from last year at this time.

Presently we are helping \$15 per client due to extremely low funds.

United Way's quarterly allocation of \$44,541.75 and an additional \$1,790 from private donations was not enough to help clients at our usual rate with the increased requests that we have received. We are expecting to receive some funds from FEMA but those funds can only be used for rent or mortgage payments.

At this time we are requesting \$8,000 to finish out this quarter and continue into April.

In monitoring the Seneca Landfill Methane Extraction System we have had issues with several wells where water is entering the wells. Although we have capped off those wells so that it doesn't affect our ability to operate the extraction system, it is necessary for us to address this problem right away. Otherwise, methane will continue to be detected off-site, which violates regulations. We are able to reduce the amount of methane off-site by operating the methane system. However, any new system requires troubleshooting to ensure optimum performance.

Goldie and Associates has provided us with a scope of services for this project. The first phase will involve testing the liquid in the wells and evaluating liquid levels in the wells over a period of a month to determine if they are fluctuating. With a better estimate of the volume of liquid in the wells, budget numbers can be further defined for the next phase of work. **The cost of Phase I will be \$6,000.**

Phase II could involve one of two alternatives. The first alternative would entail installing new wells. The second would involve pumping the leachate and treating it. After discussing the alternatives with Robert and Goldie, I am recommending that we plan for pumping the leachate. We have no way of guaranteeing that this will correct the problem, but it is more likely to than if we were to drill new wells that could also be percolated by water in the area. **The cost of Phase II, Alternate II is currently estimated to be \$36,500.** However, this will be dependent upon the leachate test results and the number of loads of leachate that must be treated.

If the above action does not correct the problem, a third phase would be necessary, involving permanently mounting pumps in the wells. **A conservative estimate of capital costs for Phase III would be \$75,000.** Then, there would be an on-going cost of treating the leachate at approximately \$900 a load. If the liquid tests comparable to the condensate that naturally collects in the pipeline, it should be less costly to treat.

While I understand that the deadline for purchase orders has passed, this is a safety issue that we should at least begin addressing this year. I received the scope of services information the week that the FY04 Budget was due, and have been evaluating our current budget as we submitted end-of-the-year purchase orders to determine where funds might be available for this project. The Testing Wells account has \$28,000 left, since we re-bid groundwater monitoring and saved \$3,500 and clarified with DHEC that the Seneca Landfill no longer requires storm water testing since the MSW portion is closed, and since we did not need all of funds allocated for Goldie to monitor the methane system. I would like to ask for approval to change the line item justification to allow for \$28,000 to be utilized to begin work on this project. I have budgeted funds in the FY04 budget to cover part of Phase II and if necessary, Phase III, in next year's budget. Thank you for your consideration of this request.

Dear Ms. Grant:

As requested, Goldie & Associates is providing professional engineering services for the above referenced project. We will be providing Oconee County with services that will address the apparent problems with the methane wells at the landfill across from Mr. Rains Property along Strawberry Farm Road. The final scope of services will be dependent on a variety of factors that will be discovered through the project. We recommend that the project move forward in phases. The following is our proposed scope of services in a phased format:

SCOPE OF SERVICES - PHASE I:

- Test the leachate in the methane wells to determine whether the liquid is hazardous and the treatability of the liquid. This information will be useful in determining which of the following alternates to take
- Evaluate the liquid level in other wells to determine extent of problem.
- Evaluate the liquid levels in the wells after one month to determine if levels are fluctuating.
- Estimate the volume of liquid in the wells by comparing new and historic data in methane venting wells and groundwater monitoring wells.
- Evaluate data, recommend alternate, and further define budget number.

The cost for these services would be \$6,000.

PHASE II:

ALTERNATE I

Alternate one entails installing new methane extraction wells that penetrate further and deeper into the solid waste mass. The intent of this alternate is that we can get under the perched water table. The proposed scope would be as follows:

- Propose new well locations and submit a plan to DHFC for review and approval
- Install four new methane wells
- Connect the ^{FLOW} wells to the existing header pipe
- Evaluate the water levels in the new and surrounding wells
- Observe effectiveness of new wells on methane levels
- Recommend further action if necessary

BUDGET FOR ALTERNATE I:

The following budget is based on installing four wells 80' deep, well heads, and hooking the wells into the main header pipe. We recommend a budget of \$50,000. This assumes that the perched water table will not impede the drilling. This dollar amount does not account for unsuccessful borings that will require hole abandonment and re-drilling another vent. This estimate assumes that the County will provide the necessary stone for the vents at the landfill and provide a low sided open top container to place the waste that is excavated from the landfill. This estimate assumes that the County will dispose of the waste at the transfer station with no tipping fee.

ALTERNATE II:

Alternate II would be to pump out the leachate from the existing wells. This will require pumping the leachate out of the wells and transporting it to a WWTP for treatment.

BUDGET FOR ALTERNATE II:

Fees for this phase will be highly dependent on a number of variables. At this time, there is no feasible way of estimating the amount of leachate that will need to be pumped and treated. We have provided a mobilization fee and cost per load for transportation and treatment.

Mobilization Fee for the Pumping the Leachate: \$13,750

Cost per load of Leachate: \$900*

Assuming that 10 loads (approximately 25,000 thousands gallons) is pumped and treated, then a budget of \$27,750 would be reasonable. At this time we anticipate that this is a very conservative figure.

*Does not include surcharges for BOD, TSS, and COD. Additional treatment charges may apply.

The Division has reviewed the above-referenced document as submitted by Goldie & Associates on behalf of Oconee County and offers the following comments.

The above-referenced document requests a time period of three to four months in which to conduct a feasibility study, locate a source of clay for the cap, and prepare a cost estimate for the installation of a Subtitle D cap on the Phase II portion of the landfill. The Department believes that sixty (60) days is sufficient to perform this study.

A workplan, which would meet these goals, should be submitted to the attention of Jenny Mowbray of the Department's Facility Permitting Section on or before May 11, 2003. If a subtitle D cap is to be proposed, the workplan should detail the construction of the cap and provide a timeline for this process.

As requested, Goldie & Associates is providing professional engineering services for the above referenced project. We will be providing Oconee County with a Landfill Closure Investigation for the Seneca Landfill. We foresee an investigation that will explore the feasibility and costs associated with closing the landfill in conjunction with building the new C&D landfill, a new mulch staging area, a potential C&D material recycling area, and site preparation for a new Manned Convenience Center. We recommend the following scope of services to complete this project:

SCOPE OF SERVICES:

- Evaluate existing site and soil data on the landfill and the old hospital property borrow sites
- Geotechnical field evaluation of soils at the old hospital property and landfill borrow sites
- Permeability testing of soils at the old hospital property and landfill borrow sites
- Topographic survey of old hospital property site
- Estimate quantities of suitable soil available for a clay cap at both sites
- Survey test hole locations
- Perform laboratory testing on inferior soils to determine effectiveness of adding bentonite to soil material to meet specifications
- Perform cost estimates of closure activities and estimate cost of total project (including C&D landfill construction, etc.)
- Explore possibilities of utilizing other borrow sites or re-permitting past borrow sites not previously utilized
- Develop a report of findings and recommendations
- Review report & plans with Oconee County personnel
- Respond to DHEC's request for a work plan to correct the groundwater problem

ENGINEERING FEES

The cost for the above scope of services will not exceed \$23,800. This price assumes that the county will have a backhoe and operator available for the field analysis of the soils at the borrow sites.

PILOT STUDY

If not enough "good" clay can be found at the old hospital property and landfill borrow site and the economics look favorable for using bentonite to bring inferior soils up to the required specifications, then we recommend performing a pilot study. The pilot study would consist of building an approximately 20' by 20' test strip to verify the effectiveness of using a bentonite admixtures in the existing clays. At this time we estimate the cost of a pilot study to be approximately \$4,000 to \$5,000 *contingency*

SCHEDULE

We recommend that additional time beyond the February 28, 2002 deadline be requested from DHEC to complete this study. The additional time will be needed to accurately collect and analyze the data and to propose the most cost effective solution to this problem.

AN ORDINANCE REGULATING ACCESS TO AND CONDUCT AT OR IN OCONEE COUNTY GOVERNMENTAL MEETINGS, FACILITIES AND PROPERTY, AND INTERACTIONS WITH OCONEE COUNTY DEPARTMENTS, OFFICIALS AND EMPLOYEES.

SECTION 1: PURPOSE

The Oconee County Council has determined that it is necessary to regulate access to county facilities, grounds and property in order to ensure the safety and security of the public who visit these areas and of the county employees who serve them. The conduct of persons who visit county facilities and/or who have contact with county employees must also be regulated to preserve public order, peace and safety. The regulation of access and conduct must be balanced with the right of the public to have reasonable access to public facilities and to receive friendly, professional service from county employees.

SECTION 2: DEFINITIONS

- (A) "Meeting", as used herein, shall mean any assemblage of persons for the purpose of conducting Oconee County governmental business, operations or functions or any assemblage of persons within an Oconee County governmental facility. "Meeting" includes but is not limited to: Oconee County Council meetings and committee meetings, trials, hearings and other proceedings conducted in the Courts of General Sessions and Common Pleas, Family Court, Master-in-Equity, Probate Court and Magistrate's Court, and other meetings by entities duly authorized by the governing body of Oconee County.
- (B) "Facility", as used herein, shall mean any building, structure, or real property owned, leased, rented, operated or occupied by the County of Oconee or one of its departments, offices or agencies.

SECTION 3: PROHIBITIONS

It shall be unlawful for any person to:

- (A) utter loud, obscene, profane, threatening or abusive language or to engage in any disorderly or disruptive conduct that impedes, disrupts or disturbs the orderly proceedings of any meeting, or operations of any department or function of Oconee County government.
- (B) interfere with, impede, hinder or obstruct any Oconee County governmental official or employee in the performance of his or her duties, whether or not on Oconee County government property.

SECTION 4: PENALTY

Any person violating the provisions of this ordinance shall be deemed guilty of a misdemeanor and upon conviction shall be fined not less than twenty-five (\$25.00) dollars nor more than five hundred (\$500.00), or imprisoned for not more than thirty (30) days for each violation.

In addition, vehicles that are improperly parked on any county premises may be towed by law enforcement officers at the owner's expense.

SECTION 5: SEVERABILITY

If any section, paragraph, provision, article or word of this ordinance is invalidated by any court of competent jurisdiction, the remaining sections, paragraphs, provisions, articles and words shall not be affected and shall continue in full force and effect.

- (C) enter any area of an Oconee County governmental facility, grounds or property when such entry is prohibited by signs, or obstructed or enclosed by gates, fencing or other physical barriers. Such areas include areas if clearly marked with signs to prohibit unauthorized entry.
- (D) enter by vehicle any area of an Oconee County governmental facility, grounds or property when such entry is prohibited by signs or markings or are obstructed by physical barriers; or park a vehicle in said restricted areas; or park in a manner to block, partially block or impede the passage of traffic in driveways; or park within fifteen (15) feet of a fire hydrant or in a fire zone; or park in any area not designated as a parking space; or park in a handicapped parking space without proper placarding or license plate; or park in a reserved parking space without authorization.
- (E) use any Oconee County governmental facility, grounds or other property for any purpose not authorized by law or permitted by officials responsible for the premises.
- (F) enter without authorization or permission or refuse to leave any Oconee County governmental facility, grounds or other property after hours of operation.
- (G) obstruct or impede passage within a building, grounds or other property of any Oconee County governmental facility.
- (H) enter, without legal cause or good excuse, an Oconee County governmental facility, grounds or property after having been warned not to do so; or, having entered said property, fail and refuse without legal cause or good excuse to leave immediately upon being ordered or requested to do so by an official, employee, agent or representative responsible for the premises.
- (I) damage, deface, injure or attempt to damage, deface or injure any Oconee County governmental property, whether real property or otherwise.
- (J) enter or attempt to enter any restricted or non-public ingress point or any restricted access area, or bypass or attempt to bypass the designated public entrance or security checkpoint of a facility without authorization or permission.
- (K) perform any act which circumvents, disables or interferes with or attempts to circumvent, disable or interfere with a facility's security system, alarm system, camera system, door lock or other intrusion prevention or detection device. This includes opening, blocking open or otherwise disabling an alarmed or locked door or other opening that could allow the entry of an unauthorized person into a facility or restricted access area of the facility.
- (L) exit or attempt to exit a facility through an unauthorized egress point or alarmed door.
