Mr. Redd Gardner addressed Council with his thoughts that more ambulance substations may be needed in certain areas of the County and went on to discuss his traffic and intersection concerns in the Fair Play area near Yoder's Building Supply and near the Newry community in Seneca.

Mr. Frankie Pearson addressed Council with his opinion that there is a lack of adequate police and fire personnel to protect the growing population of Oconee County.

Mr. Elliott stated that he is concerned with density around the lakes and wants to define the Lake Overlay Ordinance in more detail for the undeveloped lake frontage property.

Mr. Elliott made a motion, seconded by Mr. Cain, to direct staff to revise the Lake Overlay Ordinance, section 38-11.1.(d)(1)a.1., to include the following wording, "Any lot, any portion of which lies within 200 feet of the full pine contour, shall have a minimum size of one-half acre, existing lots would be grandfathered in and therefore not under the restriction of one-half acre", and to bring back to Council.

Mr. Davis again clarified with Mr. Elliott that existing lake front and interior lots would not be under this restriction and only future lake frontage development would be affected with the amendment to the Lake Overlay Ordinance.

Motion approved 3 - 1, Mr. Hart opposed.

Mr. Cain noted that after the very productive meeting with Council and OJRSA today, he was approached by a board member to schedule a follow up meeting and asked Ms. Brock, County Administrator, to reach out to OJRSA to schedule.

Ms. Brock asked Mr. Cain if the scheduling of the follow up meeting could be passed to the Council Clerk and he noted that would be ok to do so.

Mr. Davis addressed Mr. Gardner regarding his traffic and intersection concerns in Fair Play.

Mr. Davis addressed Mr. Pearson noting that on his Strategic Plan for 2023, he wanted 4 officer positions to be added.

Mr. Davis offered his appreciation to Mr. Brunson for the presentation to Council and thanked Council for the funding that was allotted to the City of Westminster that allowed the water system improvements.

A portion of Local ATAX revenues received by Oconee County are made available for ATAX grants through Ordinance 2011-12. ATAX grants are to be tourism related grants that meet the ATAX guidelines specified by local and State mandates. Grants are recommended by the PRT Commission based on tourism impact of the project and approved by County Council. All external ATAX grant recipients are required to turn in intermediate reports every 60 days to the progress of the grant and a final report upon completion of the grant. These reports are placed in the grant folder, which is kept active by the PRT staff until the grant is considered complete. Internal projects through Oconee PRT are also funneled through local ATAX for eligible projects.

It is the staff's recommendation that Council approve of ATAX grant recommendations as presented.

Mr. Davis made a motion, seconded by Mr. Cain, to approve of ATAX grant recommendation as presented.

Mr. Hart asked Mr. Phil Shirley, PRT Director, if funding from ATAX is being used as payment for the property purchase at Chau Ram Park.

Mr. Shirley confirmed that an annual allotment from ATAX funds is taken out in July of each year for payment on the land purchase at Chau Ram.

The existing paved parking area at the Oconee County Regional Airport does not have enough spaces to effectively accommodate the volume of vehicle traffic utilizing the Airport. The grassy area behind the terminal building is being used as overflow parking and has increased due to heavier Aircraft traffic volume, rental cars, long term parking customers, and County citizens visiting the Airport. The excess number of vehicles also possesses a safety concern; large mail/supply delivery trucks and emergency response vehicles have a hard time navigating the packed parking areas. The overflow lot becomes congested with day to day customers getting blocked in or having to maneuver around obstacles. This project will

This construction project will consist of: demolition, site preparation, earthwork, soil erosion control, aggregate base course, rip-rap, asphaltic concreted binder / surface courses (SC), traffic striping, storm drainage, grassing and site concrete. This project will be running simultaneously with another project, Runway Rehabilitation, at the Airport.

On August 23, 2022 formal sealed bids were opened. Thirty-one (31) companies were notified of this bid opportunity. One bid was received from S & S Construction, Inc., of Anderson, SC, in the amount of \$248,762.60, plus a 10% contingency in the amount of \$24,876.26, for a total of \$273,638.86.

It is the staff's recommendation that Council:

- 1. Approve the award of ITB 22-01 to S & S Construction, Inc., of Anderson, SC in the amount of \$248,762.60, plus a 10% contingency of \$24,876.26, for a total award of \$273,638.86.
- 2. Authorize the County Administrator to execute documents for this project and sign any change orders within the contingency amount.
- 3. Authorize the County Administrator to transfer sufficient funds for the above project to the departments Capital Departmental Paving line item.

Mr. Davis made a motion, seconded by Mr. Cain, to approve the award of ITB 22-01 to S & S Construction, Inc., of Anderson, SC in the amount of \$248,762.60, plus a 10% contingency of \$ 24,876.26, for a total award of \$ 273,638.86, authorize the County Administrator to execute documents for this project and sign any change orders within the contingency amount, and authorize the County Administrator to transfer sufficient funds for the above project to the departments Capital Departmental Paving line item.

Ms. Brock noted to Council that she received an update from the South Carolina Aeronautics Commission, encouraging Oconee County to apply for additional grant funding that could be up to a fifty percent match on the above stated request.

Ms. Brock further noted that any unexpended funds for the above mentioned purpose would roll back to fund balance and would not be expended as a general budgetary item.

Mr. Davis inquired if this item was included in the FY 2022-2023 budget.

Ms. Brock explained the above request was included in the FY 2022-2023 budget, noting to Council what page the item could be found on in the budget book.

Council consideration and approval of funding in an amount not to exceed \$1,500,000 for site enhancement activities at Golden Corner Commerce Park.

Golden Corner Commerce Park (GCCP) is a 320+ acre industrial property owned by Oconee County located two miles from Interstate 85. The property is served by water, sewer, electric and natural gas, all of which have sizeable capacities capable of supporting large scale industrial projects. The property is considered one of the best industrial sites between Atlanta, GA, and Raleigh, NC. Over the past several years, this site has drawn considerable interest from a number of large-scale manufacturing projects.

The inability to secure one or more businesses at GCCP can be directly tied to the property's undeveloped and raw status. While infrastructure is located at the site, no work has been done to prepare the property for development and is a major consideration when businesses are evaluating locations in multiple states. No portion of GCCP has been cleared or graded, and its topography appears challenging to many prospective businesses. The Oconee Economic Alliance (OEA) believes that creating a cleared and graded 60-90-acre area, with 40-60 acres that are pad ready and running parallel to Highway 59, will significantly increase the marketability of the property. Completion of this work, will put Oconee County in a far better position to successfully compete for sizable manufacturing projects that are considering GCCP. This type of initiative was done at Oconee Industry and Technology Park and the impressive build-out of that location is a direct result of Oconee County clearing and grading it. OEA believes similar results will be forthcoming at GCCP.
