# Call to Order

Mr. Elliott called the meeting to order at 6:00 p.m.

Mr. Elliott opened the meeting reminding the public they have two opportunities to speak during Council meetings, which is during the public comment session and also during the public hearing session, if scheduled. Other than those two instances, the public should remain silent during the Council meeting. Anyone making a disturbance during the meeting will be asked to leave Council Chambers for the remainder of the meeting.

Mr. Cain made a motion, seconded by Mr. Davis, approved 4 - 0, to approve the September 6, 2022 regular meeting minutes as presented.

Mr. Cain made a motion, seconded by Mr. Davis, approved 4 - 0, to approve the September 13, 2022 Millage Workshop minutes as presented.

#### **Attorney's Comments**

Mr. Root addressed Council with the following topics:

- 1. A motion to amend the agenda is needed to place Project Queso Grant Agreement under Action Item(s) in order meet a submission deadline.
- Mr. Cain made a motion, seconded by Mr. Davis, approved 4 0, to amend the agenda to add the following action item: Authorize the County Administrator to execute and deliver the Project Queso Grant Agreement (in backup and provided earlier today to Council by email), the Performance Agreement (upon receipt), and any related documents, all in order to foster a grant from the State of South Carolina of \$200,000 to Project Queso (Curtec) for site improvement costs.
- 2. If **Ordinance 2022-22** passes first reading it will then be forwarded to the Planning Commission pursuant to the Oconee County Code of Ordinances for a public hearing and their report, noting this process requires a 30-day notice of hearing and it would be a while before it returns to Council.
- 3. In relation to **Ordinance 2022-23**, Mr. Root informed Council that he is currently working with Ben Olsen with the Department of Transportation and with Kyle Reid, Oconee County Assistant Director of Public Works, to ensure the ordinance language references the Department of Transportation standards.
- 4. **Ordinance 2022-24**, related to proposed amendments to lot size and density provisions in a portion of the Lake Overlay, will be required to go to the Planning Commission before third reading for a report and their recommendation. Mr. Root also noted that notifications by mail will be sent to affected residents and recommended a public posting as well, noting the more notice the better.

Mrs. Hubbard noted that if the home was valued at \$100,000 last year and the value remained at \$100,000 this year, you would not see a tax increase but if your home increased in value with the reassessment, your taxes would slightly increase.

Mr. Elliot, Council Chair, noted that Mr. Mize would need to meet with Mr. Root, County Attorney, to sign a non-disclosure agreement before he would be able to join in on Executive Sessions.

Mr. Hart made a motion, seconded by Mr. Cain, instructing staff to complete the necessary documents with Mr. Mize that will allow him to join Executive Sessions before he takes Council District III seat in January 2023.

Mr. Root informed Council there is not rule as to a set date that Mr. Mize could start attending Execution Sessions.

ORDINANCE 2022-21 AN ORDINANCE TO SUPPLEMENT ORDINANCE 2021-14, WHICH APPROPRIATED AND AUTHORIZED THE EXPENDITURE OF TWO MILLION AND 00/100 (\$2,000,000.00) DOLLARS OF LOCAL CORONAVIRUS FISCAL RECOVERY FUNDING RECEIVED BY OCONEE COUNTY ("COUNTY") UNDER THE AMERICAN RESCUE PLAN ACT OF 2021 ("ARPA") FOR PURPOSES OF THE SALEM WATER INFRASTRUCTURE PROJECT ("PROJECT"), BY APPROPRIATING AND AUTHORIZING THE EXPENDITURE OF AN ADDITIONAL FIVE HUNDRED, FIFTY THOUSAND, AND 00/100 (\$550,000.00) DOLLARS FOR THE PROJECT, SO THAT THE TOTAL APPROPRIATION AND EXPENDITURE AUTHORIZATION FOR THE PROJECT WILL NOW TOTAL TWO MILLION, FIVE HUNDRED, FIFTY THOUSAND, AND 00/100 (\$2,550,000.00) DOLLARS; AND OTHER MATTERS RELATED THERETO.

Mr. Cain made a motion, seconded by Mr. Davis, to approve **Ordinance 2022-22** on first reading.

Mr. Hart commented that if this added step makes this process simpler, he will go along with it.

Mr. Davis then clarified with Council Chair, Mr. Elliott that **Ordinance 2022-22** would now be forwarded to the Planning Commission for their review.

Mr. Root, County Attorney, confirmed Mr. Davis' statement, noting that the Planning Commission will give a 30-day notice of a public hearing, then will review and issue their report, putting this back to Council at a November or December meeting.

**ORDINANCE 2022-23** AN ORDINANCE AMENDING CHAPTER 26 OF THE OCONEE COUNTY CODE OF ORDINANCES, IN CERTAIN LIMITED REGARDS AND PARTICULARS ONLY, TO ALLOW FOR THE CONSTRUCTION OF SIDEWALKS IN COUNTY RIGHT-OF-WAYS; AND OTHER MATTERS RELATED THERETO.

Mr. Cain made a motion, seconded by Mr. Davis, to approve **Ordinance 2022-23**, on first reading.

Mr. Davis questioned if **Ordinance 2022-23** will be referred to the Planning Commission as well.

Mr. Root, County Attorney, noted **Ordinance 2022-23** came from the Planning Commission with his (Mr. Root) revisions and that he will also be in communication with the Department of Transportation regarding the wording of **Ordinance 2022-23** and its drawings before second reading.
