I. ADMINISTRATION OF OATH OF OFFICE

The Person selected by the Members to administer oaths shall call the meeting to Order and administer the oaths of office to the Members. Such person shall also call upon the Members of Council to elect from its own number a Temporary Chairman and, upon such election, the Temporary Chairman shall take charge of the meeting.

II. ADOPTION OF ORDINANCE 75.1

The Temporary Chairman shall announce that each Member of the Council has had in their respective possessions copies of the Ordinance which is the organizational Ordinance for the Council. The Temporary Chairman shall call for a motion of adoption and a second to such motion, which shall also include that the Ordinance take immediate effect upon its adoption, and upon such motion being duly made and seconded and unanimously adopted, the Temporary Chairman shall declare the same to be adopted and of full force and effect.

III. ELECTION OF OFFICERS

The Temporary Chairman shall first call for the election of the Chairman of the County Council, and upon such election the duly elected Chairman shall then and there take charge of the meeting. The Chairman shall then call for an election of the Vice Chairman, and upon such election, shall declare such person to be the duly designated Vice Chairman. The Chairman shall then call for nominations and the election of a Clerk to the Council. Upon such nomination and election, the Clerk shall be appointed, and if the Clerk is present, the Chairman shall ask the Clerk to immediately assume the duties of the office.

IV. SELECTION OF TIME AND PLACE FOR REGULAR MEETINGS
OF COUNTY COUNCIL

The Chairman shall ask the membership to discuss and select a time and meeting place for regularly scheduled meetings of County Council. (It appeared that the concensus of opinion would be that the County Council would meet on the first and third Thursdays of each month, at the County Council offices, in the former County Health Building, at 8:00 o'clock, p. m. The Chairman may announce that from time to time the Council would hold its meetings in other locations and at other times, and that the public would be given due notice of such changes by publication of the time and place being posted in the County Courthouse, and further, that the press would be notified of such changes well in advance of the meeting.

- VII. STATEMENT OF CHAIRMAN TO ALL PERSONS ATTENDING THE MEETING PERTAINING TO THE FOLLOWING
