## MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular Oconee County Council Meeting was held August 3, 1982 at 7:00 P.M. in Council Chambers with all members present.

Members of the press present: Dave Givens - Greenville News, George Allgood - WGOG Radio, Cobb Oxford - Seneca Journal & Ashton Hester - Keowee Courier.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Mr. Williams.

Mr. Butts made a motion, seconded by Dr. Earle, approved 5 - 0 to adopt the minutes of the July 20, 1982 meeting.

Dr. Earle presented Ordinance 82-8, "Setting Fees for Landfills" and made a motion it be adopted on third and final reading. This motion was seconded by Mr. Butts, approved 5-0.

Mr. Butts made a motion, seconded by Mr. Brandt, approved 5 - 0 that Ordinance 82-9, "Industrial Revenue Bonds for Torrington Mfg. Co." be adopted on third and final reading.

Mr. Williams made a motion, seconded by Mr. Brandt, approved 5 - 0 that \$761.56 be taken from line item 22 12 00 1 for temporary help in the Solicitor's Office.

Mr. Harper made a motion, seconded by Mr. Williams, approved 5 - 0 that \$1,000 be taken from contingency for carpet in the new offices for Juvenile & Aftercare. This office will be moving from the courthouse into the Rock Building.

Mr. Harper made a motion, seconded by Mr. Williams, approved 5 - 0 that Byerley, Duncan & Co. be awarded the bid for the 1982-83 audit, they were low bidder at \$14,950.

Mr. Harper presented the bids for work to be done at the Planning Commission. Low bidder was B & F Roofing of Greenville but Council deemed it would be wise to study all bids before making a decision.

Mr. Crain announced there would be a Public Hearing August 17, 1982 at 3:00 P.M. concerning disposition of several subdivision roads which were conditionally accepted under the 1975 Ordinance. (See attached list)

Mr. Crain Announced that a notice of the Public Hearing would be hand delivered to each house in these subdivisions.

Mr. Crain announced that Oconee County had received a total of \$43,700 as restitution for the missing gasoline:

Mr. Crain and several Council Members expressed satisfaction with the settlement that had been reached.
