

MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held Tuesday, February 21, 1984 at 3:00 PM in Council Chambers with all members present.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Mr. Harper.

Mr. Butts made a motion, seconded by Dr. Earle, approved 5 - 0 that the minutes of the February 7, 1984 meeting be adopted as printed.

First on the agenda was a public hearing to receive written and/or oral comments concerning the 1983-84 Supplemental Appropriations Ordinance to include \$727,195 in Revenue Sharing Funds. There was no one present with written and/or oral comments.

After a brief discussion by Council, Mr. Williams made a motion, seconded by Mr. Butts, approved 5 - 0 that Ordinance 84-1, "1983-84 Supplemental Appropriations Ordinance" be adopted on second reading.

Mr. Brandt made a motion, seconded by Mr. Butts, approved 5 - 0 that the Sheriff use \$1,050 presently in account number 04 84 00 3 and \$2,500 from contingency to install a safe with a cage around it.

Mr. Brandt made a motion, seconded by Mr. Harper, approved 4 - 1 (Mr. Butts voting against) that the Tax Collector's position be made an appointed position to be hired by Council, with salary to be set by Council and this individual be under the direct supervision of the County Treasurer.

Mr. Crain again stated his opposition to making this an appointed position. Mr. Butts stated he was not convinced this would save the county any money.

On February 14, 1984 Council met with Mr. O. C. McLane & Dr. A. A. Martin to discuss some road problems. Mr. Butts, Chairman of the Roads & Transportation Committee stated that although Council would like to work these roads they are not on record as county roads and cannot be worked by the county.

When Council went back into open session Dr. Earle made a motion, seconded by Mr. Butts, approved 5 - 0 that one of the deputies salaries be raised from entry level of \$10,686 to \$11,420 due to his fifteen years experience.
