## MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular Oconee County Council Meeting was held Tuesday, September 4, 1984 at 7:00 PM in Council Chambers with all Council Members present.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was offered by Mr. Butts.

Dr. Earle made a motion, seconded by Mr. Williams, approved 5 - 0 to adopt the minutes of the August 21, 1984 meeting as printed.

Mr. Brandt made a motion, seconded by Dr. Earle, approved 5 - 0 to adopt Ordinance 84-7, "Law Enforcement Center Policies & Procedures" on third and final reading.

On the recommendation of Mr. William H. Sample, Project Manager, State Budget & Control Board, Mr. Harper made a motion, seconded by Dr. Earle, approved 5 - 0 to accept the low bid of Diamond Construction Co. & Barnes Sheet Metal at \$202,549 upon approval of the county attorney. (see attached bid)

Director, Mr. Harper made a motion, seconded by Mr. Williams to
accept the low bid of Southland Safety Supply for a fire truck at
\$79,893.53 including tax. (see attached copy of bids & specifications)

Dr. Earle made a motion, seconded by Mr. Brandt, approved 5 - 0 that Mr. Williams make a recommendation at the September 18, 1984 meeting on disposing of the cattle owned by the county.

After a brief discussion Mr. Brandt made a motion, seconded by Mr. Butts, approved 4-1 (Mr. Harper voting against) to deny the request of the DeMolay Organization to have a haunted house in the old Oconee County Jail due to the unsafety of the old building.

Mr. Brandt recognized Mr. Bob Busch, LEC Director, who displayed prospective uniforms for the inmates to wear to Council. Mr. Brandt also presented to Council a cost figure sheet on how much money using the inmates has saved the county in personnel costs.

After considerable discussion, Dr. Earle made a motion, seconded by Mr. Williams, approved 3 - 2 (Mr. Brandt & Mr. Harper voting against) that factory made uniforms be provided for the inmates at an estimated cost of \$8,193.12 coming from line item 74 65 00 1. The uniforms are to be blue with a white strip down the leg and the inmates who will be working in extreme environments where the uniforms will get soiled are to wear fatigues with a white stripe down the leg. Also, if line item 74 65 00 1 is depleted before the end of the fiscal year funds will come from contingency.

Dr. Earle presented Council with a brief job description for the Computer Manager and said he hoped to have a meeting of the Computer Committee in the near future.

Mr. Harper made a motion, seconded by Mr. Butts, approved 5 - 0 to offer to lease from R. Scott Alexander & Helen C. Alexander the old "Green Mt. Realty Building" for the Seneca Magistrate's Office. The rent on the building is \$275 per month, it will take about \$1,000 to rennovate the building, the first month's rent will go toward the rennovation and the county will have the option to renew the lease for two one year terms.

Mr. Brandt made a motion, seconded by Mr. Butts, approved 5 - 0 to transfer title to a 1968 Ford Station Wagon, serial number 8A38F209636 back to the Mountain Rest Rescue Unit so it can be sold and the money used for squad needs.

Mr. Williams informed Council he had been appointed to serve a a member of the Advisory Council of the Erosion & Sediment Committee.

Mr. Harper made a motion, seconded by Dr. Earle, approved 5 - 0 that Mr. Jack L. Mooneyham's resignation from the Emergency Preparedness Commission be accepted and Mr. Michael D. Clayton be appointed to replace him with the term commencing immediately and expiring December 31, 1987.
