MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held September 18, 1984 at 3:00 PM in Council Chambers with all members present.

Members of the press notified (by mail): Seneca Journal, Keowee Courier, Greenville News, Anderson Independent, WGOG Radio & WSNW Radio.

Press

The invocation was offered by Mr. Brandt.

Dr. Earle made a motion, seconded by Mr. Harper, approved 5 - O that the minutes of the September 4, 1984 meeting be adopted as printed.

Minutes

Mr. Chris Foreman of Clemson University presented Council with the attached recommendations concerning the use of the county computer. Mr. Crain asked the Computer Committee to review this presentation and make a recommendation on it at the next Council Meeting.

Computer

Mr. Brandt had to leave at this time.

At the recommendation of Mr. Kenneth F. Williams, County Auditor, Mr. Williams made a motion, seconded by Mr. Butts, approved 4 - 0 (Mr. Brandt absent) that the county millage remain at 124 mills.

At the recommendation of Mr. Robert Gaillard, Dr. Earle made a motion, seconded by Mr. Butts approved 4 - 0 (Mr. Brandt absent) to apply for funding for the extension of the county sewer line to serve Jacob's Mfg. Co. The total cost of the project is estimated at \$351,000. Jacob's portion of this is approximately \$88,250.

Ms. Lisa Horne presented to Council a waste oil recycling program, Mr. Williams made a motion, seconded by Dr. Earle, approved 4 - 0 (Mr. Brandt absent) that Council endorse this program.

Dr. Earle reported that the Intergovernmental & Personnel Committee had been contacted by the Clemson University Historical Department concerning Lunney Museum. They are wanting to work with the county on this, the committee has agreed to cooperate with them and no action has been taken pending a meeting with the Historical Department.

Mr. Butts made a motion, seconded by Mr. Williams, approved 4-0 (Mr. Brandt absent) that the attached personnel transfer in the Sheriff's Department be made.

Sheriff Holcombe also presented Council with the attached letter concerning the bingo ordinance. Mr. Crain informed him this ordinance is still in committee as there is a question about who would enforce the ordinance. Sheriff Holcombe indicated he would be willing to enforce the ordinance.

Mr. Williams made a motion, seconded by Dr. Earle, approved 4 - 0 (Mr. Brandt absent) to transfer \$59,280 from funds budgeted for health insurance in the various departments into contingency. This was overbudgeted due to incorrect figures given to the county by Blue Cross/Blue Shield. (see attached copy of transfer)

Mr. Williams made a motion, seconded by Mr. Butts, approved 4 - 0 (Mr. Brandt absent) to accept the proposal of John C. Taylor Stockyard of Anderson to pick up the cattle on October 13, 1984 at a cost of \$60.00 for hauling the cattle and the cattle be sold at auction October 15, 1984. Mr. Williams will attend the sale of the cattle.

Dr. Earle made a motion, seconded by Mr. Butts, approved 4 - 0 (Mr. Brandt absent) to pay Mrs. Nettie Keys an extra \$250.00 per month as acting Library Director retroactive to August 10, 1984 until such time as a Library Director is appointed. The funds will come from line item 10 11 00 1 (Library Director salary).

Dr. Earle made a motion, seconded by Mr. Williams, approved 4 - 0 (Mr. Brandt absent) to adopt the attached Rural Fire Contract in which the county will maintain a private road to a lake for the Rural Fire Department to use as a water source.

Dr. Earle made a motion, seconded by Mr. Harper, approved 4 - 0 (Mr. Brandt absent) to adopt the attached contract for dental health for the migrants.

Dr. Earle invited all Council Members and elected officials to the COG Meeting, Friday, September 28, 1984 at 10:00 AM.

Dr. Earle made a motion, seconded by Mr. Butts, approved 4 - 0 (Mr. Brandt absent) that the attached application for special assessment for agricultural property be approved as per Resolution 80-9. Mr. Medford, County Assessor recommended this be approved due to illness and the death of the owner.

Council agreed by general concensus the use of two rooms downstairs in the dourthouse by the Election Commission.

The Ebenezer Community Club has requested gravel for their new building, Mr. Crain referred this to the Roads & Transportation Committee and asked for a recommendation at the next Council Meeting if possible.

Mr. Crain asked the Building & Grounds Committee to make a recommendation on the empty buildings Oconee County owns. It was agreed they should be advertised for rent.

Mr. Hunnicutt informed Council there were certain things Oconee County is going to have to do to comply with handicapped regulations. Mr. Ken Williams, Chairman of the Committee, will make a complete list of recommendations at the next Council Meeting. Mr. Williams made a motion, seconded by Dr. Earle, approved $4-0~({\rm Mr.}~{\rm Brandt~absent})$ to take \$500 from contingency to begin working on these things.

It was decided that the Motor Pool Committee would meet September 25, 1984 at 6:30 PM in Council Chambers.
