MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held December 15, 1987 at 3:00 PM in Council Chambers with all Council Members and the County Attorney present.

Members of the press notified (by mail): Seneca Journal, Keowee Courier, Anderson Independent, Greenville News, WGOG Radio, WSNW Radio, WLOS TV & WYFF TV.

All other persons who have asked to be notified of meetings were also notified by mail.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Mr. Harper.

Dr. Earle made a motion, seconded by Mr. Butts, approved 5-0 that the minutes of the December 1, 1987 meeting be adopted as printed.

First on the agenda was a public hearing concerning the moving of eight (8) graves recently located in the Lake Hartwell Fair Play Recreational Area. (See attached list of persons attending hearing)

 $$\operatorname{Mr.}$ Crain read the attached letters from Mr. Gary Isbell and Mr. Hal Gene Isbell who believe their relatives are buried in the graves.

Mr. Crain had talked Ms. Geraldine Royster who had heard of the site and she thinks the graves should be moved to Beaverdam Baptist Church as does several other people that were contacted concerning the matter.

Ms. Wanda Childs was contacted concerning the matter but she had no knowledge of the matter.

Ms. Debbie Justus felt the graves should be moved.

Mrs. Fred Isbell had no comment concerning the matter.

Mr. M. C. Sheriff, representing the Historical Society, felt the graves should be preserved by building a wall around the graves so the water could not get to them when the lake is at its highest level.

Mr. Clint Isbell who felt that these are graves of his descendants would like for the government to determine whose graves they are and a historical marker be put up. Press

Mr. George Carnes who lives in the area said his father told him it was Isbells who lived there and a Mr. Strandrege used the markers as piers for his hours.

Mr. Charles E. Herring stated he felt it should be handled in a dignified manner.

Mrs. Louise Corbett stated she felt the graves should remain where they are and a peninsula should be built around them to keep the water off the graves.

There were seven (7) people who attended the hearing who felt there were related to the persons buried, none of these were in agreement that the graves should be moved to Beaverdam Baptist Church.

After considerable discussion Mr. Dyar made a motion, seconded by Mr. Butts, approved 5-0 that the Corps of Engineers refigure the cost of building a peninsula out to the gravesite and if it is at all financially feasible to construct such a peninsula and erect an appropriate monument in honor of the persons buried in the graves.

At the request of Solicitor George Ducworth, Mr. Butts made a motion, seconded by Dr. Earle, approved 5 - 0 that the Solicitor's Office be allowed to transfer funds within the department to hire a part time assistant solicitor for the remainder of this fiscal year. (See attached request)

Mr. Horace Padgett of Elliott, Davis & Co. addressed Council concerning the audit for the 1986-87 fiscal year. Mr. Padgett noted that: 1) Fixed asset records detailing date acquired, actual costs, or estimated historical cost of assets should be maintained and that the county is in the process of implementing such a system; 2) The county has experienced problems in the costing of parts inventory but is in the process of revising this inventory pricing system; 3) The Oconee County Rock Crusher is very profitable and revenue generated by that facility has been previously considered as a part of the general fund but should be handled as an enterprise fund; 4) That Oconee County is in excellent financial condition.

Dr. Earle made a motion, seconded by Mr. Butts, approved 5 - 0 to replace Patient's Choice Health Insurance, which terminates December 31, 1987 with a self funded plan as proposed by Agent Hawkins & Marke, P. O. Box 2999, Greenville, S. C. 29601. General Administrators, Inc., P. O. Box 5430, Greenville, S. C. 29606 will be administrators of the plan and stop/loss insurance will be provided by Certain Underwriters at Lloyd's of London. The premiums for dependent coverage will remain the same as with Patient's Choice through June 30, 1987 and the county's cost will be \$20,954 more than Patient's Choice and will come from contingency. The benefits will be basically the same as Patient's Choice. The coverage will be for an eighteen (18) month period beginning January 1, 1988.
