Mr. Williams made a motion, seconded by Mr. Butts, approved 4 - 0 (Dr. Earle absent) that Resolution 87-16, A Resolution Authorizing the Execution and Delivery of an Assistance Agreement By and Between Oconee County, South Carolina, and Cascade Corporation, Whereby, Under Certain Conditions, Oconee County Will Issue Not Exceeding Eight Million Dollars (\$8,000,000) Industrial Development Revenue Bonds or Notes" be adopted on first and final reading.


