## MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held Tuesday, August 19, 1988 at 3:00 PM in Council Chambers with all Council Members and the County Attorney present.

All other persons who have requested to be notified of meetings were also notified by mail.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Mr. Harper.

Mr. Dyar made a motion, seconded by Dr. Earle, approved 5-0 that the minutes of the August 2, 1988 meeting be adopted as printed.

Mr. Dyar made a motion, seconded by Dr. Earle, approved 5-0 that the minutes of the June 23, 1988 special meeting be adopted as printed.

Ms. Margie White addressed Council concerning a master JTPA Contract, Mr. Dyar made a motion, seconded by Dr. Earle that Oconee County enter into this master contract so that when a department requests a JTPA worker they will not have to wait until the next Council Meeting to have this request approved.

After discussion, in which the County Attorney stated he would have to check with JTPA to see what is required for each individual hired under this program, Mr. Dyar withdrew his motion.

Mr. Williams made a motion, seconded by Mr. Dyar, approved 5 - 0 to award the bid for a REX 3-55B compactor for the CCS Department to Van Lott, Inc. at a cost of \$183,337.35 with \$98,670 coming from line item number 10 049 00150 00870 in the CCS Department and \$84,887.35 coming from contingency.

Dr. Earle reported to Council that at the South Carolina Association of Counties Meeting there was a discussion of state mandates on counties and DHEC regulations, also there was a discussion of health insurance with a self funding program being sponsored by the South Carolina Retirement System. Dr. Earle further informed Council the "Alternate Source of Revenue" bill would be back in the next session of legislation.
