MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held Tuesday, April 4, 1989 at 7:00 PM in Council Chambers with all Council Members and the County Attorney present.

Members of the press notified (by mail): Seneca Journal, Keowee Courier, Greenville News, Anderson Independent, WGOG Radio, WSNW Radio, WBES Radio, WYFF TV & WLOS TV.

All other persons who have asked to be notified of meetings were also notified by mail.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Mr. Dyar.

Dr. Earle made a motion, seconded by Mr. Stone, approved 5-0 that the minutes of the March 21, 1989 meeting be adopted as printed.

Mr. Nic Church, Mr. Dick Baird, Mr. Tommy Oglsby and Mr. Dave Powell of Department of Youth Services addressed Council regarding the concept of a "Marine Institute". Mr. Church informed Council this program is for fifteen and sixteen year old youths who have committed offenses who need to be somewhere, but do not need to be placed in jail with criminals. Mr. Church also informed Council that violent offenders are screened from this program. The Department of Youth Services likes for these institutes to be near water and have a wilderness atmosphere.

This is a six months program and at the end of this six months the youth is placed in a job or back in school.

After discussion, Mr. Church asked how Council felt about having the program based at the "Wilderness Camp" in Fair Play. There was concern about the fact that there is only one road into the camp, also Council expressed the consensus they would not mind a "Marine Institute" being located in Oconee County if the people of the area were not unhappy about it being there. There were also feelings that the school system should spend more time with troubled youngsters.

Mr. Dyar made a motion, seconded by Dr. Earle, approved 5-0 that Mr. Billy Smith's request for \$4,900 be taken from contingency and placed into maintenance accounts for the remainder of the fiscal year:

Dr. Earle made a motion, seconded by Mr. Dyar, approved 5-0 that \$3,600 be taken from contingency and placed in line items 10~039~00110~03900, Board Members Salaries - \$2,750 and 10~039~00150~00017, in county travel - \$850 for the Board of Assessment Appeals.

Dr. Earle made a motion, seconded by Mr. Stone, approved 5 - 0 that \$1,000 be taken from contingency and placed in line item number 10 025 00150 00025, postage for the Delinquent Tax Collector's Office.

Dr. Earle made a motion, seconded by Mr. Dyar, approved 5-0 that Council go into executive session for a briefing by the County Attorney on 7-Q-10.

When Council resumed open session, after a brief discussion regarding the aerial platform fire truck Council adjourned at 9:30 PM.
