Mr. Dyar made a motion, seconded by Dr. Earle, approved 5 - 0 that Stone Castle Auction Sales be awarded the bid for auctioneering services for the county auction, they were low bid at \$133.50. (See attached bid)

The Parks, Recreation & Tourism Commission Members: Mr. David Land, Chairman; Mr. Glen Cox, Mr. Clint Richardson, Mr. John Barnett & Mr. Billy Littleton addressed Council regarding the commission's input into the operation of the parks.

PRT Discussion

The commission members indicated they did not have a copy of the ordinance creating the PRT Commission and they were unclear as to what their responsibilities were.

After some discussion, the commission was informed there would be interviews for the PRT Director Thursday, October 19, 1989 at 8:30 AM in Council Chambers and they were welcome to sit in on these interviews. They were also assured Council would work with them in any way possible to make the operation of the parks smooth and the Council Clerk would get them copies of the ordinance.

Dr. Earle made a motion, seconded by Mr. Dyar, approved 5 - 0 that \$166.50 be transferred from general funds into line item 10 012 00200 02004. The court ordered these funds paid to Oconee County by a person who damaged a deputy's vehicle while being arrested. (See attachment)


Restitution
