MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held Tuesday, September 18, 1990 at 3:00 PM in Council Chambers with all Council Members and the County Attorney present.

All other persons who have asked to be notified of meetings were also notified by mail.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Mr. Harper.

Mr. Stone made a motion, seconded by Dr. Earle, approved 5 - 0 that the minutes of the regular meeting held September 4, 1990 be adopted as printed.

Mr. Strickland made a motion, seconded by Mr. Stone, approved 5 - 0 that the minutes of the special meeting held September 12, 1990 be adopted as printed.

Dr. Earle made a motion, seconded by Mr. Stone, approved 5 - 0 that Walter Pelfrey be awarded the bid for a storage building for the Sheriff's Department at a total cost of \$14,991.95. (See attached bid)

Dr. Earle made a motion, seconded by Mr. Harper, approved 5 - 0 that the attached three (3) arts contracts be approved.

Mr. Francis Gaillard, PRT Director, addressed Council regarding a mobile home for the park system. The bid placed asked for a 14'X70' used mobile home. However, the only bid received for a used mobile home was a 12'X56' 1968 mobile home. There were three (3) alternate bids received for new mobile homes, however the costs of these mobile homes exceed the budgeted amount. Mr. Gaillard requested additional funds to purchase a new mobile home.

After discussion, Dr. Earle made a motion, seconded by Mr. Dyar, approved 5 - 0 that PRT scrutinize their budget to see where some funds could be transferred and place a bid for a new mobile home with two (2) baths and three (3) bedrooms (one to be used for an office).

Dr. Earle made a motion, seconded by Mr. Strickland, approved 5 - 0 that Ordinance 90-10, "An Ordinance to Amend Article VII, Section 3.2 of Ordinance 79-4 to Increase the Penalties for Violations of Ordinance 79-4 from TWO HUNDRED AND NO/100 (\$200.00) DOLLARS Per Day Per Violation to TWO THOUSAND AND NO/100 (\$2,000.00) DOLLARS Per Day Per Violation to Provide for Enforcement of the Penalties as Provided in Section 6-11-285 of the South Carolina Code of Laws, 1976, as Amended" be adopted on second reading.

Mr. Harper asked Council Members to think about whether they would like to lease animal cages from the Humane Society or purchase cages.

Mr. Jack Hirst addressed Council regarding monitoring wells for the landfills.
