MINUTES, SPECIAL MEETING, OCONEE COUNTY COUNCIL

There was a special meeting of the Oconee County Council Tuesday, June 25, 1991 at 3:00 PM in Council Chambers with all members of Council and the County Attorney present.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

Call to Order

The invocation was given by Mr. Harper.

Invocation

Mr. Strickland made a motion, seconded by Mrs. Burrell that Ordinance 91-5, "1991-92 Oconee County Budget Ordinance" be adopted on third and final reading.

Ord. 91-5

Mr. Robert Gaillard, Planning Commission Director, addressed Council regarding carrying forward in the 1991-92 budget \$50,000 in line item 10 058 00110 00025 due to the fact that there is not sufficient time in this fiscal year to issue a purchase order for an engineer to update the 201 study.

Mr. Harper made a motion, seconded by Mr. Strickland, approved 4 - 0 that the budget be amended to included the attached list of changes.

The budget ordinance was then adopted 4 - 0 on third and final reading.

Next there was discussion regarding budgetary matters at Lakeview Rest Home. Mr. Crain Supervisor-Chairman stated he felt the county could give Lakeview a grant, if necessary so they could handle their own payroll, insurance, etc. However, he also stated the county would not cut them off if they were unable to do this at this time, he further asked that if there were major problems at Lakeview that someone be appointed as a point of contact.

At the request of Mr. Bob Busch, LEC Director, and Mrs. Marianne Dillard, Purchasing Director, Mr. Strickland made a motion, seconded by Mr. Stone, approved 4 - 0 that up to \$8,500 be taken from contingency and the bid process be waived to purchase a fire alarm system for the Oconee County Law Enforcement Center.
