MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held Tuesday, May 19, 1992 at 3:00 PM in Council Chambers with all Council Members and the County Attorney present.

The meeting was called to order by Super-visor-Chairman Crain who welcomed the guests and media.

Call to Order

Mr. Stone made a motion, seconded by Mrs. Burrell, approved 5 - 0 that the minutes of the May 5, 1992 meeting be adopted as printed.

Mr. Donald, Chairman of the Budget & Finance Committee, informed those present that any raise that he and his wife would receive as employees of the School District for the 1992-93 fiscal year would be given to charity. (See attached letter of explanation)

Budget

Mr. James B. Brown, Superintendent of Education, Mr. Jim Bridges & Mr. John Lay presented the attached proposed 1992-93 budget for Oconee County School District to Council.

School Budget

Mr. Brown informed Council the drop out rates in the Oconee Schools were dropping. He further informed Council that seventy-five percent (75%) of the expected \$6,000,000 windfall expected from the Bad Creek project would be assigned to non recurring projects. Mr. Brown also stated that there were 1244 employees in the school district at the beginning of the year and they were hoping to give them a 6% pay increase.

The teacher ratio in Oconee County is one (1) to nineteen (19), there are twenty-two (22) schools in the county and approximately 10,000 students.

Mr. Brown further informed Council the focus of the School District is on the classroom.
