## MINUTES, SPECIAL MEETING, OCONEE COUNTY COUNCIL

There was a special meeting of the Oconee County Council held October 26, 1992 at 9:00 AM in Council Chambers with all Council Members and the County Attorney present.

Members of the press notified: Westminster News, Keowee Courier, Journal Tribune, Anderson Independent, Greenville News, WGOG Radio, WSNW Radio, WCCP Radio, WZLI/WLET Radio, WYFF TV & WLOS TV.

There were no members of the press present.

The meeting was called to order by Supervisor-Chairman Crain who welcomed the guests and media.

The invocation was given by Mr. Donald.

The purpose of the meeting was to discuss and consider action to be taken regarding Dusty Lane - WA 244 & Cuddle Cove Road.

Mr. Crain informed Council that in order for the county to go onto private property and work, Council must determine that the county caused the problem on the roadway.

There was considerable discussion regarding the condition of the roadway and who caused the problem.

Certain of the Council Members had not seen the roadway in question and deemed it necessary to view the problem before voting on the matter.

Before moving on to the field trip to view the problem, Council took action regarding old and new business matters.

At the request of Mr. Hunnicutt, Finance Director, Mr. Strickland made a motion, seconded by Mr. Stone, approved 5 - 0 that \$2,339 be taken from contingency and placed in line item 10 036 00120 36121 for temporary personnel while the permanent personnel is out on sick leave.

Mr. Cain, County Attorney, advised Council that if they determined the county was at fault regarding the roadway problem, the county should enter into a contract with Ms. Moore and as a part of that contract that once the work is done the county be released from any further damage.

At 9:50 AM Mr. Cain, County Attorney, Mr. Harper, Mr. Strickland & Mr. Stone went on field trip to view the roadway problem.

Field Trip

When the Council returned from the field trip, after discussion, Mr. Stone made a motion, seconded by Mrs. Burrell, defeated 2 - 3 (Mr. Strickland, Mr. Donald & Mr. Harper voting against) the county had indeed caused the water problem Ms. Moore was experiencing on her driveway and the county follow all legal procedures to repair and open the ditch on her private driveway on a one time basis. Also that the county and the land owner enter into an agreement as approved by the county attorney.

After the motion was defeated, Mr. Crain and each of the Council Members gave Ms. Moore a personal check in the amount of \$25 to replace the gravel on her driveway.

Mr. Donald made a motion, seconded by Mr. Strick-land, approved 5 - 0 that Resolution 92-7, "A Resolution Designating November, 1992 as Hospice Month" be adopted on first and final reading.
