**MINUTES, OCONEE COUNTY COUNCIL MEETING**

The regular meeting of the Oconee County Council was held Tuesday, July 8, 1993 at 7:00 PM in Council Chambers with all Council Members present. Mr. Cain, County Attorney was also present.

Mr. Harper made a motion, seconded by Mr. Strickland, approved 5 - 0 that the bid for chemical spraying for the roads be awarded to Green Pastures, Inc. (See attached bid sheet)

Upon recommendation of Mr. Michael Willimon, Aeronautics Commission Chairman, Mr. Strickland made a motion, seconded by Mr. Harper, approved 5 - 0 that the county apply for a grant in the amount of \$470,709 which is a 5% state funding match and a 5% local funding match for a total amount of \$523,010 for the aircraft apron expansion.

Mr. Strickland made a motion, seconded by Mrs. Burrell, approved 5 - 0 that Mr. Frank Lanford and Mr. Fred Hamilton be reappointed to the Private Industry Council with terms commencing July 1, 1993 and expiring June 30, 1996.

Mr. Williams made a motion, seconded by Mr. Orr, approved 5 - 0 that Wachovia Bank of North Carolina, N.A. be allowed to replace Oconee County Pollution Control Revenue Bond, Series A (Duke Power Company Project) 9.125% dtd 5/1/83 due 5/1/2013 Lost Bond R-149 @ \$5,000 R/NO John F. Reames II.

At the request of Mr. Cain, County Attorney, Mr. Harper made a motion, seconded by Mr. Orr, approved 5 - 0 that Council go into executive session for a legal briefing.

Mr. Crain also informed Council that he had also received the appraisal for the Battle Clinic in Seneca which was appraised for \$120,000.

Rosa Clark

Mr. Williams made a motion, seconded by Mr. Harper that the county proceed with applying for a grant for the purchase of this building for the Rosa Clark Clinic.

Mr. Orr stated that he wanted to go on record as opposing this project because he was afraid that at some future date the county would have to fund the operation of this project.

The motion to commit to this project was adopted 4 - 1 (Mr. Orr voting against).

Mr. Strickland made a motion, seconded by Mrs. Burrell, approved 4 - 1 (Mr. Orr voting against) that the option for the purchase of this building be \$3,500.

The Roads & Transportation Committee scheduled a meeting Tuesday, July 13, 1993 at 8:30 AM for the purpose of discussing the road priority formula and three (3) bridges that need to be replaced.
