MINUTES, EMERGENCY MEETING, OCONEE COUNTY COUNCIL

The Oconee County Council held an emergency meeting as authorized by Section 4-9-130 Subsection 6, Code of Laws of South Carolina and per Section 8.3.3 of Oconee County Ordinande 85-1, Wednesday, December 15, 1993 at 5:30 pm in Council Chambers with all County Members and the County Attorney present.

Members of the press notified (by phone): Keowee Courier, Journal/Tribune, Westminster News, WGOG Radio & WBFM Radio.

Press

Members of the press present: Dick Mangrum -WGOG Radio.

The meeting was called to order by Supervisor-Chairman Crain.

The invocation was given by Mr. Orr.

Mr. Michael Willimon, Aeronautics Commission Chairman, informed Council that Fixed Base Operator of the airport had allowed the av gas to become depleted. However, there is approximately seven hundred (700) gallons of jet fuel in the tanks and he feels that will be enough to last through mid January, 1994 as there is not as much jet fuel used in the winter as the summer.

Ms. Marianne Dillard, Purchasing Director, informed Council that if the County were to purchase less than 8,000 gallons of av gas the cost to the County would be \$1.38.2 per gallon, however if the County were to purchase in excess of 8,000 gallons, the cost would be \$1.24 per gallon.

It was Ms. Dillard's recommendation that the County purchase fuel from one vendor and if there is a problem with the fuel, the County would know who to contact. She further recommended that the County purchase fuel from Eastern Aviation under Section C, 4 "When in the Purchasing Agent's judgement, and with concurrence of County Council, it is to the advantage of the County's interest to do so".

Council recessed go give Mr. Cain an opportunity to write the emergency ordinance.

Mr. Harper made a motion, seconded by Mr. Orr, approved 5 - 0 that Ordinance 93-9, "An Emergency Ordinance Authorizing the Sale of Fuel at the Oconee County Airport by Oconee County on a Temporary Basis" be adopted on first and final reading.
