MINUTES, OCONEE COUNTY COUNCIL MEETING

The regular meeting of the Oconee County Council was held Tuesday, July 19, 1994 at 3:00 pm in Council Chambers with all Council Members except Mr. Harper present. Mr. Strickland came in at 3:05 pm. The County Attorney was also present.

Members of the press notified (by mail): Journal/Tribune, Keowee Courier, Westminster News, Anderson Independent, Greenville News, WGOG Radio, WBFM Radio, WCCP Radio, WZLI/WLET Radio, WYFF TV, WLOS TV & SC Black Media Group.

Press

Members of the press present: Ashton Hester - Keowee Courier, Kathleen Stoll - Anderson Independent, Dick Mangrum - WGOG Radio, Allen Bowie - Greenville News and Alan Adams - Journal/Tribune.

The meeting was called to order by Supervisor Chairman Crain who welcomed the guests and media.

Call to Order

The invocation was given by Mr. Orr.

Invocation

Mrs. Burrell made a motion, seconded by Mr. Orr, approved 3 - 0 (Mr. Harper absent, Mr. Strickland had not come in at this time) that the minutes of the regular meeting held July 5, 1994 be adopted as printed.

Minutes (7/5/94)

Mr. Alex James, PRT Director and Ms. Jenny Peay, Purchasing Assistant, requested that the attached bid for boat slips and repairing of courtesy docks at High Falls & South Cove County Parks be altered for Oconee County to dispose of the floatation and wood on the existing docks and let Custom Steel renovate the two boat slips at High Falls Park and build a new courtesy dock at South Cove Park at a total cost of \$17,500.

However, Mr. Cain, County Attorney, advised against this as the negotiation with the low bidder changed the scope of work from the original bid specifications.

There was no motion to adopt this recommen-

dation.

At the request of Chief Deputy F. Steve Pruitt, representing Sheriff Singleton, Mr. Strickland made a motion, seconded by Mr. Williams, approved 4 - 0 (Mr. Harper absent) that the Sheriff's Department be allowed to use \$892.50 DEA Funds to purchase a trailer for the all terrain vehicle and \$1,429.50 DEA Funds to purchase a radio for the under cover

narcotics officer's vehicle.

Mrs. Burrell made a motion, seconded by Mr. Williams, approved 4 - 0 (Mr. Harper absent) that the minutes of the special meeting held July 7, 1994 be adopted as printed.

Minutes (7/7/94)

At the request of Mr. Bob Busch, LEC Director, Mr. Strickland made a motion, seconded by Mrs. Burrell, approved 4 - 0 (Mr. Harper absent) that \$20,508.19 be taken from contingency and used to create a personnel position in the Law Enforcement Center to replace a Correctional Officer who has been out due to an injury on the job since February 4, 1994. This will leave the position open for the officer who is out as well as allow a full staff at the LEC. Also the first female officer to resign will not be replaced.

LEC (Cont'cy)

At the request of Mr. Charles Himelrick,
Assistant Vice President, Phoenix Cable Incorporated, Mr.
Strickland made a motion, seconded by Mrs. Burrell, approved 3 1 (Mr. Harper absent, Mr. Orr voting against) to endorse the
rate increase for Phoenix Cable of \$1.50 per month adding six (6)
new channels. (See attachment)

Phoenix Cable TV

Dr. Ed Byars appeared before Council to discuss developments concerning Hidden Glen/Eagle Ridge Airport.

Eagle Ridge

Mr. Cain, County Attorney, suggested that Council listen attentively to Dr. Byars regarding Hidden Glen/ Eagle Ridge, but advised Council to make no comment or reply at this time.

Dr. Byars asked Council to send a message that they were acting in good faith by making a motion to change the county flight pattern. He further stated that if Council did not pass such a motion it would send a message that Council is not negotiating in good faith, that the County is continuing to take punitive action against Eagle Ridge.

Dr Byars also stated that he hoped Council would not hide behind legal advice and further study.

Mr. Cain, County Attorney, stated that he strongly disagreed with Dr. Byar's statement that such unilateral action on the part of the county would not prejudice the county in any way. Title 55-5-120 states that it shall be unlawful for any airport, landing field, air school, flying club, air beacon or other air navigation facility to be used or operated without the approval of the SC Aeronautics Commission. All proposed airports, landing fields, air fields, flying clubs, air beacons or other air navigational facilities shall first be approved by the commission before they or any of them shall be used or operated. The Commission may issue a certificate of approval in each case.

Mr. Cain further informed Council that this has been the law since before Hidden Glen was built and is the law today.

Mr. Cain further advised Council to make no comment or reply at this time as Dr. Byars and his attorneys have threatened to sue Oconee County. Mr. Cain stated that although it is a free country and anyone can speak to anyone at any time they wish to, Council may prejudice their position and the position of Oconee County in the future.

Mr. Cain also informed Council that Dr. Byars has retained excellent attorneys and anything Council may say at any time may be used against them in court later.

Further, Mr. Cain indicated that Council will be called upon in the near future to decide whether to enter into an agreement with the private airport group which will alter the normal existing landing and take off pattern at the public airport. Council has been briefed in the past and will be given additional information prior to a special meeting with the Oconee County Aeronautics Commission to consider the agreement with Hidden Glen/Eagle Ridge.

Mr. Cain informed Council that at the end of last week he received the minutes of the teleconference held by the SC Aeronautics Commission which he requested from Dr. Byars over a month ago and this will be given to the Council Members. Mr. Cain further advised Council to take no action at this time.

Mrs. Burrell stated she received more information off the street that she did in Council Meetings regarding the airport. Mr. Cain assured Council they would have additional information before they were asked to make a decision regarding Hidden Glen/Eagle Ridge.

In further discussion, Mr. Crain stated the way Council acted when asked to go into executive session lead the County Attorney and himself to believe that they did not want to go into executive session for briefings. Mr. Crain also stated that at the last Council Meeting when Mr. Cain mentioned an executive session, the Council Members said "O, no! not an executive session".

However, the Council Members disagreed saying they had never refused to go into executive session, they had always listened to the briefings and they did not appreciate being reprimanded in public.

Mr. Crain then offered to recess the meeting and obtain the tapes from the last meeting and play the tapes in open session to remind Council what was said, however, there was

no request or motion to do this.

Mrs. Burrell asked that it be made a part of the record that she had not been guilty of not listening to information given when Council is in executive session.

Dr. Byars further stated he did not wish to go against Title 55-5-120, SC Code of Laws, but he did want Council to pass a motion to change the flight pattern of the Clemson-Oconee County Airport.

There was no motion made.

Mr. Williams made a motion, seconded by Mrs. Burrell, approved 4-0 (Mr. Harper absent) that Council go on record opposing public nudity and Council will do what it can to stop it.

Public Nudity

Mr. Strickland made a motion, seconded by Mr. Orr, approved 4 - 0 (Mr. Harper absent) that Flex Road be changed to Watts Rd with the landowner paying to change the signs.

Flex Rd.

To Mr. Orr's inquiry, Mr. Crain informed Council that no roadways to be paved had been removed from the list given to Council.

Paving List

At the request of Mr. Cain, County Attorney, Mr. Orr made a motion, seconded by Mr. Strickland, approved 4 - 0 (Mr. Harper absent) that Council go into executive session for the discussion of legal and contractural matters.

Executive Session

When open session resumed, Mr. Strickland made a motion, seconded by Mrs. Burrell, approved 4 - 0 (Mr. Harper absent) that the administration be authorized to proceed with the acquisition of two (2) acres on Hwy. 11 near the interstate for a manned convenience center as well as title from the SC Highway Department for an easement and to obtain title insurance on this property.

Open Session

Mr. Strickland made a motion, seconded by Mr. Orr, approved 3 - 2 (Mr. Harper absent, Mr. Crain breaking tie) that the administration be authorized to obtain another six (6) month option on the three hundred, twelve (312) acre site for a proposed landfill and modifying the agreement to give the current landowners the first right of refusal to purchase the land back from the county and also give them access to any test results on the property.



County Cablevision has conducted a subscriber program survey and is considering adding the following channels:

- 1) SportsSouth
- 2) Turner Classic Movies classic older movies
- 3) TNT Turner Network NFL, NBA movies, etc.
- 4) WOR Superstation New York
- 5) USA movies, series, sports, etc.
- 6) Weather Channel

It would be possible to add these channels before the end of August, 1994 and possibly by early August should we obtain the quick concurrences of the Town to allow us to increase rates by \$1.50 by September 1, 1994. 

Dear Council Member:

As you know, County Cable included in its billing in late 1993, a survey regarding a possible addition of channels to our lineup. At that time we thought we might add three (3) channels, but after many letters and phone calls from our subcribers indicating the desire for more than three (3) channels we have decided on six (6). Most of the subscribers that we have either received a letter from or spoken with directly, indicated they would be willing to pay an increase for more quality channels.

The channels we propose to add are high quality, much demanded programming including:

√1.

USA - sports, movies, series - most watched cable programming in America

Weather Channel - including local weather

SportsSouth - south and southeast sports

TNT - sports (NFL, NBA, etc.), movies - one of the most popular programmers

5. TCM - Turner Classic Movies - from the thirties through the eighties

WOR - superstation from New York; sports (Mets), movies, news, etc.

They do not come cheaply, equipment and programming costs alone amount to \$1.78 per subscriber. We are asking for a price increase of \$1.50. We are obviously going to loose \$.28 per subscriber the first year and more the following couple of years as programming costs rise each year.

We are willing to absorb this loss in order to satisfy our customers and hopefully the system will grow.

We are unable to add these channels without an increase, so we ask you to approve the \$1.50 increase. As our information indicates, people are willing to pay the increase for the quality channel being added.

We look forward to providing quality programming as we strive to offer ever improving service.
