Mr. Thomas made a motion, seconded by Mr. Timms that Ordinance 97-2, "OCONEE COUNTY, SOUTH CAROLINA LAND USE PLAN, DATED FEBRUARY, 1996, AMENDED AUGUST 1997" be adopted on third and final reading.

The ordinance as amended was then adopted 4 - 1 (Mrs. Hughes voting against)

Mrs. Hughes then went on record stating she based her vote on input from citizens in District IV as well as other citizens in the county and although there were parts of the ordinance she could support, there were parts she could not support, therefore she could not vote in favor of the plan.
