Upon request of Mr. Robert Galloway, Bond Counsel, of Sinkler & Boyd & Mr. John Geer of Duke Power Company, Mr. Hamilton made a motion, seconded by Mrs. Hughes, approved 4 - 0 (Ms. Burrell absent) that Resolution 97-17, "A RESOLUTION APPROVING THE ISSUANCE BY OCONEE COUNTY, SOUTH CAROLINA, OF ITS POLLUTION CONTROL, SOLID WASTE AND/OR SEWAGE DISPOSAL FACILITIES REVENUE BONDS (DUKE ENERGY CORPORATION PROJECT) PURSUANT TO THE PROVISIONS OF TITLE 48, CHAPTER 3, CODE OF LAWS OF SOUTH CAROLINA 1976, AS AMENDED, IN THE PRINCIPAL AMOUNT OF NOT EXCEEDING \$35,000,000; MAKING APPLICATION TO THE STATE BUDGET AND CONTROL BOARD OF SOUTH CAROLINA FOR APPROVAL OF THE ISSUANCE OF THE BONDS AND AN ALLOCATION OF STATE CEILING FOR PRIVATE ACTIVITY BONDS; AND PROVIDING FOR OTHER MATTERS RELATING THERETO" be adopted on first and final reading.
