**MINUTES, SPECIAL MEETING, OCONEE COUNTY COUNCIL**

The Oconee County Council held a special meeting Tuesday, August 29,2000 at 12:30 PM with Mrs. Hughes, Mr. Hamilton & Mr. Hall present.

**Press:**

Members of the press notified (by mail): Journal/Tribune, Keowee Courier, Westminster News, Anderson Independent, WGOG Radio, WPEK Radio & WYFF TV.

Members of the press present: Catherine Hunter – Journal/Tribune

**Call to Order:**

The meeting was called to order by Supervisor-Chairman Orr who welcomed those present.

**Invocation:**

The invocation was given by Mr. Hall.

**Seneca Library Roof (Contingency):**

Upon recommendation of Mr. Jon Caime, County Engineer and Ms. Marianne Dillard, Procurement Director, Mr. Hall made a motion, seconded by Mr. Hamilton, approved 3 – 0 that \$4,677 be taken from contingency to complete the funding and the bid for re-roofing the Seneca Library be awarded to Carolina Roofing at a cost of \$46,777 for the base bid and \$5,400 for alternate #3. The total award was for \$54,777 which includes a 5% contingency. (See attached bid sheet)

**Old Veterans Affairs Office:**

Upon request of Mr. Caime, Mrs. Hughes made a motion, seconded by Mr. Hamilton, approved 3 – 0 that if the individual who expressed an interest in the old Veterans Affairs office is no longer interested in salvaging the building it be demolished and disposed of at the landfill.

**BellSouth Request:**

Mr. Hamilton made a motion, seconded by Mrs. Hughes, approved 3 – 0 that the attached request of BellSouth for an easement on county property at the intersection of Shiloh Road and Airport Road for a substation be adopted pending approval of the County Attorney.

**Recess of Council Meeting:**

At 12:50 PM Mr. Hamilton made a motion, seconded by Mr. Hall to adjourn the meeting, however this motion was withdrawn and Mr. Hamilton made a motion, seconded by Mr. Hall, approved 3 – 0 that the meeting be recessed until 5:00 PM.

**Reconvening of Meeting:**

The special meeting of Council reconvened at 5:00 PM with all Council Members and Mimlinger Wiggins, Acting Attorney present.

**Press:**

Members of the press present: Dick Mangrum – WGOG Radio & Dave Williams – Anderson Independent.

**Call to Order:**

This portion of the meeting was called to order by Vice Chairman Hamilton in the absence of Supervisor-Chairman Orr.

**Lila Doyle Expansion:**

After reading the attached statement regarding his thoughts regarding the hospital property being annexed into the City of Seneca, Mr. Hamilton made a motion, seconded by Mrs. Hughes, approved 3 – 0 that the county issue bonds in the amount of \$4,115,000 for the expansion of the Lila Doyle facility.

Mr. Hudson, President, Oconee Memorial Hospital, informed Council the board would be meeting with the City of Seneca on Monday, September 18, 2000.

Although Mr. Thomas expressed support for the motion, Mr. Thomas and Mr. Hall did not participate in this action as they are Hospital Board Members.

**Bond Millage:**

Mr. Kenneth F. Williams, County Auditor, informed Council the first payment for the Lila Doyle bond would become due September 2001 with another payment becoming due March 2002, the total of those payments will be \$397,000. Mr. Williams is expecting the bond millage to be 13.5 mills which includes both the courthouse bond and the Lila Doyle bond. Council has already adopted 182.5 operating mills; therefore the expected millage this year will be 196 mills, which is a reduction of six mills for this tax year.

**Law Enforcement, Safety, Health, Welfare & Services Committee Recommendations:**

Mr. Hall, Chair, Law Enforcement, Safety, Health, Welfare & Services Committee, informed Council it was the recommendation on the committee that the County Attorney be instructed to seek for a declaratory judgement concerning the issuance of an adult club permit as it is the opinion of the committee that the permit was not issued in accordance with the county ordinance. This recommendation was adopted unanimously.

Mr. Hall further informed Council it was the recommendation of the committee that Mr. Orr explain to Council why the other adult entertainment establishment in the county did not get a permit until November 1999. This recommendation was also adopted unanimously.

**Roads & Transportation Committee Meeting:**

Mrs. Hughes, Chair, Roads & Transportation Committee informed those present there would be a Roads & Transportation Committee Meeting Wednesday, August 30, 2000 at 5:15 PM.



RE: **Seneca Library Reroof Recommendation**

I am recommending that Oconee County Council award the reroof project to either Carolina Roofing or Greenville Roofing depending on who can complete the work at the earliest date for the following reasons:

1. All bidders warned that standing water (48 hours after a rain event) would void any warranty. We have had a problem with standing water on this roof. I highly recommend we use a tapered system with a 20-year warranty (alternate #3).
2. The low bidder did not bid on this alternate. I would recommend that we discuss with Counsel the comments of the low bidder so these comments can be addressed prior to award of this contract.
3. I recommend that we select the company that will build alternate #3 in the quickest time period. We have millions of dollars of materials and equipment in this facility and the fall period is traditionally a period of increased rain.

**RE:** Former VA Building Disposition

I am requesting permission to dispose of what is left of the former VA office building. The previously approved plan for this structure was to allow the mover of the Voter registration building to salvage the old VA section for his own use.

Jim Smith has removed a multitude of valuable building materials for reuse in other County facilities. As a result of this, the mover to the former Voter Registration building no longer has an interest in salvage of the remainder of the former VA building portion. My intention with this approval, is to demolish and dispose of the remaining portions of the former VA building section. I intend to proceed with this work immediately upon approval.

**MR. SUPERVISOR, I WOULD LIKE TO MAKE THE FOLLOWING  
PROPOSAL IN THE FORM OF A MOTION:**

1. **That** county council fund the Lila Doyle expansion in the amount of \$4,000,000 +.
2. **That** county council have the right of approval for any change in Lila Doyle's administration which might occur during the life of the supporting bonds.
3. **That** the hospital property owned by the county and by the hospital association be annexed into the City of Seneca.
4. **That** the City of Seneca accept full responsibility for the operation and ownership of the Newry water and sewage facilities upon the completion of said facilities.

**ANNEXATION RATIONALE AND ADVANTAGES:**

- a. **The** above proposal will enable the City of Seneca to annex property beyond the hospital for industrial and/or business expansion.
- b. **The** possibilities of attracting business and industry to Oconee, rather than to nearby counties, will be greatly enhanced by Oconee's being able to provide adequate sewer facilities. New businesses and industries will mean more tax money, more jobs, and a healthier economy for Oconee County and its citizens.
- c. **The** Oconee Memorial Hospital will receive a sizable reduction in utility rates by being inside city limits. Estimates for the savings have been as high as \$75,000 per year. Over a prolonged period of time, the savings will be quite significant.
- d. **The** City of Seneca will also be responsible for correcting present water problems at the hospital.
- e. **The** City of Seneca made an offer to assume ownership of the Newry water and sewer systems, upon completion of the facilities, when their annexation proposal was initially presented. Consequently, the projected cost estimate, a minimum of \$25,000, would be an additional savings for the county taxpayer. Since the county can only spend *Fees in lieu of taxes* for sewer, and at the present time those fees are very limited, it is my opinion that this proposal would greatly strengthen the county's agreement with Seneca regarding the Newry situation.

**TO THE OCONEE HOSPITAL BOARD:**

You have appropriately requested that Oconee County Council provide \$4,000,000 + in tax money to build an addition to Lila Doyle, because you do not have the bonding capacity for the project. As you know, this request will be an added cost to the taxpayers of Oconee County. Therefore, my proposal is designed to help offset some of this cost. This annexation proposal will reduce county expenditures, by eliminating maintenance costs at Newry and by providing city security at the hospital. In addition, and more importantly, sewer can be extended to other areas of the county.

*The Greenville News* recently published the unemployment rates for eight upstate counties, with Oconee County's rate being seventh. At 4.9%, Oconee's unemployment rate is more than double that of Greenville County. This is during what economists consider to be the best of times. If the economy were to take a downturn, a 9 - 10% unemployment rate would not be unreasonable. We must continue to attract high-quality businesses and industries to provide jobs for our citizens. Sewer, water, electricity, and schools are the most important criteria that business and industry inquire about when looking to locate in an area. We must be proactive rather than reactive if economic progress is to be made.

My proposal to you not only addresses the fact that you need county council's help, but it also requests your help. I urge you to carefully consider this proposal. Please look at it as a county-wide package, and please feel free to suggest reasonable alternatives.

I am encouraged that you are willing to meet with the City of Seneca to discuss this matter. It is my hope that, from this meeting, better relations and more understanding will evolve, and that all of the various entities involved (the cities of Walhalla, Westminster, and Seneca, Oconee Memorial Hospital, Blue Ridge Electric, Oconee Sewer Commission, and all of Oconee County) will immediately come together to work on a plan designed to correct the county's sewer problems, a proposal our Oconee Sewer Commission has been urging for the past several years. Thank you for your time and consideration.
