Supervisor-Chair Hughes called the meeting to order.

Invocation:

Mr. Rinehart gave the invocation.

Minutes:

Mr. Lyles made a motion, seconded by Mr. Ables, approved 5 – 0 that the minutes of the regular meeting held January 21, 2003 be adopted as printed.

Resolution 2003-02:

Mr. Johns made a motion, seconded by Mr. Rinehart, approved 5 – 0 that Resolution 2003-02, "A RESOLUTION CONGRATULATING THE FARMER FAMILY AS RECYCLING FAMILY OF THE YEAR" be adopted on first and final reading. Mrs. Hughes presented the resolution to the Farmer family.

Also, upon request of Ms. Satterfield, Mr. Johns made a motion, seconded by Mr. Moore, approved 5 – 0 that the attached transfer for the Parks Department in the amount of \$8,475 be adopted.

Emergency Management Transfer:

Solid Waste Grants:

Mr. Moore made a motion, seconded by Mr. Ables, approved 5 – 0 that Mr. Robert Manka be appointed to represent District I on the Change in Government Transition Committee.

Mr. Ables made a motion, seconded by Mr. Lyles, approved 5 – 0 that a ninth (9th) member be added to the Transition Committee.

Mr. Ables made a motion, seconded by Mr. Lyles, approved 5 – 0 that Mr. Moore and Mr. Rinehart be added to the Transition Committee as Members at Large.

Solid Waste:

Mr. Johns made a motion, seconded by Mr. Ables, approved 5 – 0 that Goldie & Associates continue methane monitoring at the Seneca Landfill.

SWAG Committee:

Mr. Norton informed those present that the Sewer Commission would be making a proposal to Council in the near future.

Ordinance 2003-01:

Upon recommendation of the Budget & Finance Committee, Council unanimously adopted Ordinance 2003-01, "2002-03 OCONEE COUNTY SUPPLEMENTAL ORDINANCE" was adopted on first reading.

Ordinance 2003-02:

Upon recommendation of the Roads & Transportation Committee, Council unanimously adopted Ordinance 2003-02, "AN ORDINANCE AMENDING ORDINANCE 82-14" was adopted on first reading.

Personnel & Intergovernmental Recommendation:

Upon recommendation of the Personnel & Intergovernmental Committee, Council unanimously adopted the following recommendations:

- (1) All county vehicles except Law Enforcement have a county decal and a CG tag
- (2) The first phase of the staffing study be implemented with the adoption of the supplemental ordinance and the remainder of the staffing study be implemented over a four (4) year period with the Council through the Budget & Finance Committee adding or deleting from the study as deemed necessary and prioritize the implementation of the study according to budget restraints beginning with the 2003-04 budget.
