direct aid funds in the 2003-04 fiscal year budget be released to the Oconee Community Theater contingent upon a contract being

in place between Oconee County and the theater.

Parks & Recreation:

Parks apply for an Upper South Carolina Piedmont Heritage Association Grant in the amount of \$10,000 and a South Carolina National Heritage Corridor Grant in the amount of \$20,000 for restoration of the Alexander/Cannon/Hill House located at High

Falls Park. Matching funds of \$10,000 are in the 2003-04 Parks budget. (See attached) Also, upon recommendation of Ms. Satterfield, Mr. Moore made a motion, seconded by Mr. Rinehart, approved 5 – 0 that recreational funds in the amount of \$350 for Tamassee-Salem and \$5,000 for Seneca be approved. **Sublease Agreement with Foxwood Hills:**

Upon request of Ms. Vickie Satterfield, Mr. Ables made a motion, seconded by Mr. Johns, approved 5 – 0 that

Mr. Lyles made a motion, seconded by Mr. Johns, approved 5-0 that Council enter into the attached Sublease Agreement Between Oconee County and Foxwood Hills Property Association, Inc. for the Mountain Bay Recreational Area. **Economic Development:** Mr. James Alexander, Economic Development Director, addressed Council regarding development of the

county's four miles of the I-85 corridor. Mr. Alexander informed Council of three major industrial projects that we could not compete for due to lack of water and sewer in that area: the first project is a Walgreen Distribution Center which went to

Anderson County and will be an investment of \$175,000,000 creating 450 jobs, the second is still pending and will be an investment of \$65,000,000 creating 350 jobs and the third is an investment of between \$200,000,000 and \$300,000,000 creating 300 jobs. This is a total of \$440,000,000 in investments creating 1100 jobs that Oconee County could not compete for due to a lack of water and sewer, Mr. Alexander suggested Council consider putting infrastructure in place while searching for property for industrial development. **Solid Waste:**

Upon recommendation of Ms. Melissa Grant, Solid Waste Director, Mr. Rinehart made a motion, seconded by Mr. Ables, approved 5-0 that the tipping fee for cross ties be \$40 per ton. (See attached) Also, upon recommendation of Ms. Grant, Mr. Ables made a motion, seconded by Mr. Johns, approved 5-0that Council adopt the concept of installing additional testing wells at the Seneca Landfill with the cost of \$48,904 coming from the closure/post closure funds and giving Engelhard the first right of refusal of methane extracted from the landfill.
