# PRT Commission Recommendations:

 \$3,850.00 / Pendleton District Commission / Printing of 100,000 "Waterfalls of Upstate South Carolina" brochures / No County Match

Oconee County has partnered with re-orders of this brochure in the past due to it's popularity. To date more than 250,000 of these brochures have been used and been made available in SC & GA.

 \$2,800.00 / Continue Contract / <u>Upcountry Brochure Service</u> to display the brochures / No County Match

Upstate Brochure Services has over 50 brochure racks in SC and over 90 in northeast GA. As the company grows so will the distribution of our brochures. The racks are placed in hotels, tourist attractions, restaurants, etc.

# ATAX Grant Requests:

 \$1,200 / Foothills Conservatory / Advertising / M.A.D. Camp and The Nutcracker / Match from SC Arts Commission - No County Match

M.A.D. Camp: This camp will benefit students involved and the community by offering high quality artistic education in voice, acting and movement for state. Historically more than 20% of the students come from outside of Oconee County. The Nutcracker: This is a highly professional presentation with rehearsals held several days a week for several months in Seneca. Typically more than half of the 60+ participants come from outside of Oconee County.

 \$1,000 / <u>Heritage Corridor Ambassadors Tour Sponsorship</u> / Sponsors - No County Match

OC PRT has partnered with the Heritage Corridor and their group tour manager to offer a rolling classroom of tourism sites to create ambassadors for promoting tourism in Oconee County. These tours have been very successful and each tour bus has been filled to capacity.

### [2] <u>Boat Ramp Lease with Army Corp of Engineers</u> [Lake Hartwell]

This request is in regards to Lease DACW21-1-82-1930, Oconee County, SC, Hartwell Project in which the county would lease from the Corp of Engineers 8 boat ramps on Lake Hartwell. The County would be responsible for maintenance on these ramps. COE can not maintain these locations and will close the ramps if the County does not choose to enter into the lease. There is an "exit clause" which states the lease may be relinquished by the lessee at any time by giving the Secretary of the Army, through the District Engineer, at least 30 days' notice in writing.

# o Re-Institute Use of Badges for Qualified Park Personnel / Mr. Phil Shirley, PRT Director

Parks, Reaction & Tourism requests to allow qualified park personnel to wear their badges when on duty in the parks. The Park Rangers are very professional, definitely understand what their authority limitations are regarding custodial arrest and always will call the Sheriffs office for assistance when they can't verbally handle a situation. The request is for Council to approve the wearing of badges by Park personnel.

# o <u>Electronic Gate Installation at South Cove Park</u> / Up to \$13,000

During a committee meeting, members of Council requested the PRT Director to do research into alternatives to allow egress for those fishing beyond 10 PM and to allow easier operational procedures for gate opening/closing at South Cove Park. It is the recommendation of the PRT Director and staff to utilize local ATAX funds and PRT grant matching funds in the existing budget to install a new electronic gate at the entrance to South Cove. The PRT Commission unanimously supported this request but did not take action as a quote was not available.

B. Bid 07-05 First Year Renewal Approval / approximately \$350,000 / Rock Ouarry

A. Request for Council guidance regarding preference for procedures for future automatic renewals for bids and RFQ's that have been previously approved by Council. Historically Councils have approved bids with approved automatic renewals as along as the product or services continues to meet the needs of the department. Typically these automatic renewals allow the departments to lock pricing for a multi-year period. Procurement is requesting Council's approval of the previous policy.

B. Bid 07-05 First Year Renewal Approval for approximately \$350,000 for the Rock Quarry for drilling and blasting. This renewal would be granted to Orica USA of Ronda, NC.

Bid # 08-28 / \$184,736.80 / Vehicle Maintenance & Rock Quarry / Tires for Heavy [5]

# Equipment

The Quarry purchases tires for six [6] loaders, six [6] off-road trucks, one [1] hydraulic forklift and one [1] motor grader. Vehicle Maintenance tires are for a John Deere pan and a Clark loader which is used by the Road Department.

It is the recommendation to award Bid #08-28 to Miller Brothers Giant Tire Services, Inc for an estimated amount of \$184,736.80, for a period of one year with the option to renew for four [4] additional one year periods and that Council authorize the County Administrator to execute these renewals provided the product/work is satisfactory.

#### [6] Bid # 08-31 / \$27,947 / Vehicle Maintenance & Solid Waste / Wheels for 826G CAT Compactor

The Caterpillar 826 CAT Compactor is used at the Seneca Landfill to push and compact construction and demolition materials. The wheels currently on the machine are the original wheels and were installed in 2004 when the machine was purchased. The cleats on the wheels are worn down to the point of having holes in them and must be replaced. It is the recommendation of the staff to award Bid #08-31 to Road Machinery Services, Inc. of Statesville, NC in the amount of \$27,947.
