Oconee County Council met on Tuesday, April 13, 2010 at 6:00 PM in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members, Interim Administrator Gene Klugh, Thomas L. Martin County Attorney and Clerk to Council, Elizabeth G. Hulse present.

Press:

Pursuant to the Freedom of Information Act, notice of the meeting, date, time, place of meeting and agenda were posted on the bulletin board at the County Administrative Offices, 415 South Pine Street, Walhalla, SC, and the County Council website [www.oconeese.com/council]. Call to Order:

Mr. Dexter called the meeting to order at 6:00 p.m.

Public Comment Session:

Mr. Bo Horne addressed Council utilizing a PowerPoint presentation [filed with these minutes] regarding concerns with Ordinances 2010-05, 2010-06 & 2010-07. He also provided Council with a handout [filed with these minutes].

Mr. Larry Linsin addressed Council regarding his concerns with Ordinances 2010-05, 2010-06 & 2010-07.

Mr. C. W. Richards addressed Council regarding his concerns with Ordinances 2010-05, 2010-06 & 2010-07.

Ms. Susie Cornelius addressed Council regarding her concerns regarding agenda item #12-5. She asked Council to delay approval until all fire contracts can be reviewed.

Extended Public Comment Session:

Proposed Sprinkler Legislation / Mr. Tom Markovich

Mr. Markovich addressed Council regarding his concerns related to pending legislation requiring mandatory sprinkler systems in all new home construction. Mr. Markovich voiced concerns related to affordable housing and adequate water supplies. He noted that Senator Alexander has drafted a bill [S.1057] in opposition to this law.

Mr. Markovich asked Council to consider drafting a letter to the Delegation in support of both the Senate and House bills [S.1027 / H.4663.

High Point/Pointe West / Mr. Neal Workman

Mr. Workman utilizing a PowerPoint Presentation [filed with these minutes] addressed Council regarding specifics related to the High Point / Pointe West proposed development. Mr. Workman stated that Point West will not be a gated community and that the public will have access to all public areas to include parks, walking paths, village shopping and the lake.

Mr. B. J. Littleton addressed Council in support of mandatory sprinklers in new home construction as it is a life safety issue.

Mr. Thrift made a motion, seconded by Mr. Corbeil to approve on second reading Ordinance 2010-05 "AUTHORIZING AND PROVIDING FOR THE ISSUANCE OF SPECIAL SOURCE REVENUE BONDS OF OCONEE COUNTY, SOUTH CAROLINA; PRESCRIBING THE FORM OF BONDS; LIMITING THE PAYMENT OF THE BONDS SOLELY TO THE PLEDGED REVENUES RECEIVED AND RETAINED BY THE COUNTY FROM THE PAYMENT OF FEES IN LIEU OF TAXES FROM CERTAIN JOINT COUNTY INDUSTRIAL AND BUSINESS PARKS AND PLEDGING THE PLEDGED REVENUES TO SUCH PAYMENT; CREATING CERTAIN FUNDS AND PROVIDING FOR PAYMENTS INTO SUCH FUNDS; AND MAKING OTHER COVENANTS AND AGREEMENTS IN CONNECTION WITH THE FOREGOING".

Mr. Thrift made a motion, seconded by Mr. McCall, approved 5-0 to approve Change Order #2 for Joy Construction, Seneca, SC., in the amount of \$38,362 for grading and stone required for the parking lot of the Tri County Tech Quick Job Development Center.

Bid #09-19 / Public Works / \$32,395.36 / Three Phase Natural Gas Generator

Mr. Thrift made a motion, seconded by Mr. Corbeil, approve 5-0 to award Bid #09-19, Three Phase Natural Gas Generator for Oconee County Public Works Facility to Essential Power, LLC, Highlands, NC., in the amount of \$32,395.36.

Oconee County Medical Plan Renewal & Nurse Practitioner Program / \$4,112,895

Mr. Corbeil made a motion, seconded by Mr. Suarez approved 4 - 1 [Mr. Dexter opposed] to [1] renew for 2010-2011 plan year with the current carrier with no change to current level of benefits or premiums, [2] initiate a Nurse Practitioner program, [3] authorize the County Administrator to execute the Nurse Practitioner Service Agreement, and [4] approve a policy change for employees hired after July 1, 2010 so that the county retiree health care ends when the retiree is eligible for Medicare.

City of Seneca Request / \$48,321

Mr. Suarez made a motion, seconded by Mr. Thrift, approved 5-0 that due to the critical nature of the services provided and the error on the County's part, that payment is made to the City of Seneca in the amount of \$48,321.46.
