# Discussion regarding Proposed Changes to the Zoning Enabling Ordinance & Other Zoning Issues:

Mr. Holbrooks reviewed with the Administrator, County Attorney, Council and Planning Commission the two handouts outlining the recommended changes to the Zoning Enabling Ordinance approved by the Planning Commission at their previous meeting. Specific areas discussed included:

- Recommendation #1: Small Area Rezoning Standard
- Recommendation #2: Adoption of two new districts [Agricultural Residential and Public & Recreation Land]
- Implementation of a fee per parcel application fee for rezoning requests Lengthy discussion followed.

In addition, the Draft Standards for Consideration to the Lake Overlay were discussed.

It was agreed that the Planning Commission wished to have additional discussions regarding several components of the recommendations listed above and that they will forward back to Council for review and additional discussion at a future meeting.
