1. <u>Change Order #2</u> / B. P. Barber / \$32,600 / Preliminary Engineering Services for Phase I Water & Sewer Improvements to 400 acre site on Highway 11

On September 14, 2010, Oconee County entered into a contract with B. P. Barber for engineering & environmental services for the 400 acre site along Highway 11. The contract included various studies and reports, a proposed site layout and a preliminary opinion of probable costs for proposed improvements. Change Order #1 for a boundary survey was approved by Council on October 5, 2010. Change Order #2 for additional services for Phase I Water & Sewer Improvements [Section B ONLY] will be include a topographic survey of the water and waste infrastructure required to bring appropriate infrastructure to the property.

It is the staff's recommendation that Council approve Change Order #2 for B. P. Barber and Associates of Columbia, SC in the amount of \$32,600 for the preliminary engineering services for Phase I Water & Sewer Improvements as indicated in [Section B ONLY] of the attached proposal for the 400 acre site along SC Highway 11. This amount is in addition to the original contract amount of \$47,350 for preliminary engineering & environmental services and \$12,800 for Change Order #1 for the boundary survey – this brings the total to \$92,750.
