ITEM TITLE:

ITB 11-04 Engineering & Permitting Services for Broadband Project FOCUS

Award ITB 11-04 to Geovision of Sylva, NC, to provide engineering/permitting construction drawings for the remaining 170 miles of Broadband Project FOCUS at the price of \$.33 per foot, for a total of \$296,208.00.

BACKGROUND DESCRIPTION:


On August 18, 2010, Oconee County received \$9.6M in Federal ARRA funding to construct a 270 mile (approximate) broadband network in the County. This project will provide critical broadband infrastructure that will benefit the County through connection of 164 Anchor Institutions and by providing much needed high speed data. The total number of households that will be passed by the project is 25,200, total businesses passed by is 2,230. The Project will be involved with approximately 75 public facilities including hospitals, schools, libraries, health care facilities and emergency shelters.

The stake drawings for 100 miles of permitting have been completed. This bid was issued to select a contractor to provide the engineering services required to secure SCDOT permits for the remaining 170 miles of the total Project FOCUS. Since the installation contractor is now being selected in three separate phases, the County wanted only one contractor to be responsible for the engineering/permitting for the remainder of the project, so these services were bid out separately, rather than being supplied by the installation contractor.

On July 28, 2011, formal sealed bids were opened for these services. Forty-eight firms were originally notified of this bid opportunity. Eight firms submitted bids, seven firms submitted "no bids", and Geovision of Sylva, NC, submitted the lowest responsive and responsible bid of \$.33 per foot, totaling \$296,208.00.

FINANCIAL IMPACT:

The FOCUS Broadband Project is funded by a \$9.6M Federal ARRA grant. The County is required to provide matching funds which will bring the total project budget amount to \$14,306,764.00.

RFP 10-28 Installation Contractor for Broadband Project FOCUS- Phase One

Award RFP 10-28 to Network Controls & Electric, Inc., of Greer, SC, to install buried fiber optic cabling throughout Oconee County for approximately 95 miles of Broadband Project FOCUS at the price of \$5.44 per foot for a total of \$2,728,704.00.

BACKGROUND DESCRIPTION:


On August 18, 2010, Oconee County received \$9.6M in Federal ARRA funding to construct a 270 mile (approximate) broadband network in the County. This project will provide critical broadband infrastructure that will benefit the County through connection of 164 Anchor Institutions and by providing much needed high speed data. The total number of households that will be passed by the project is 25,200, total businesses passed by is 2,230. The Project will be involved with approximately 75 public facilities including hospitals, schools, libraries, health care facilities and emergency shelters.

The contractor selected by this RFP will provide and place conduit and handholds in all types of soil including rock, provide fiber set up and all splicing necessary for a complete installation. The County will purchase the actual fiber separately and provide to the contractor. This project is now divided into three phases. This award is for Phase One only, of approximately 95 miles. The remaining two phases will be competitively sourced and awarded separately.

On July 14, 2011, formal sealed proposals were opened for this project. Over seventy firms were originally notified of this opportunity and twelve firms submitted proposals. The RFP Evaluation Committee consisting of Mike Powell, IT Director, Kim Wilbanks, FOCUS Project Manager, John Michael Cox, IT Systems Administrator, Lisa Simmering, GIS Analyst, Channon Chambers, Building Codes Director and Aaron Gadsby, County Planner evaluated and scored all proposals, interviewed the top three firms and unanimously recommended award to Network Controls & Electric, Inc., of Greer, SC.

FINANCIAL IMPACT:

The FOCUS Broadband Project is funded by a \$9.6M Federal ARRA grant. The County is required to provide matching funds which will bring the total project budget amount to \$14,306,764.00.
