Council took first reading in caption only on September 6, 2011 and sent the issue to the Planning Commission for review. The Commission heard the matter at their regularly scheduled meeting on November 7, 2011. After receiving public comment and staff's presentation; the Commission voted to recommend all parcels to be zoned into the Public and Recreational Lands District. Staff was asked to contact the appropriate agencies requesting input. Staff received feedback from the Lands Program Manager, Francis Marion and Sumter National Forest. Council tabled this ordinance to allow for additional review at their January 3, 2012 meeting. As stated in the Oconee County Code of Ordinances, 36-10.13; the intent of this zoning classification is to "provide for a continuation and identification of public lands and to allow for those uses typically associated with accomplishing the mission of the agency charges with the care and promotion of the land".

It's staff's recommendation that Council take 2nd reading of Ord. 2011-25 & schedule the public hearing.
