Council took first reading in caption only on April 3, 2012 and sent the issue to the Planning Commission for review. The Commission heard the matter at meeting on June 4. 2012. After receiving public comment and staff's presentation; the Commission voted to forward a recommendation to council, see attached ordinance

It is staff's recommendation that Council take Second Reading of Ordinance 2012-16, and schedule the required public hearing on or after August 21, 2012.

Second Reading of Ordinance 2012-26 "AN ORDINANCETO AMEND CHAPTER 38 "ZONING" OF THE OCONEE COUNTY CODE OF ORDINANCES, INCLUDING ALL ZONING MAPS INCORPORATED THEREIN AND THEREBY, IN CERTAIN LIMITED REGARDS AND PARTICULARS, ONLY; AND OTHER MATTERS RELATED THERETO" [Echo Hills Rezoning Request]

On May 1, 2012, County Council took First Reading (in title only) on Ordinance 2012-20 and Ordinance 2012-21, each of which authorizes the transfer of property currently within the boundary of the Echo Hills Industrial Park. When transferred, the property will be occupied by 2 single-family residences, one of which is in place and will remain as is; and the other relocated from another location on the land to the second parcel. Due to the fact that the land is currently zoned in the Industrial District (ID), the existing residence will be considered a non-conforming use, but the relocation of the residence onto the second new parcel is not permitted. Ordinance 2012-26 will initiate a rezoning of both parcels that will bring them into conformity with County standards.

Staff will provide Council with a memo at the meeting from Josh Stephens with the Planning Commission's recommendation regarding this ordinance after their July 16th meeting, and schedule the required public hearing on or after August 21, 2012.

Second Reading of Ordinance 2012-27 'AN ORDINANCE AUTHORIZING THE TRANSFER AND CONVEYANCE OF CERTAIN OCONEE COUNTY REAL PROPRTY IN THE OCONEE COUNTY COMMERNCE PARK; AND OTHER MATTERS RELATED THERETO"

This ordinance is associated with Project Cover III.

It is the staff's recommendation that Council approve Ordinance 2012-27 on second reading.

First Reading of Ordinance 2012-29 "AUTHORIZING THE ISSUANCE AND SALE OF GENERAL OBLIGATION BONDS, SERIES 2012, OF OCONEE COUNTY, SOUTH CAROLINA, IN THE PRINCIPAL AMOUNT OF NOT EXCEEDING \$1,600,000; FIXING THE FORM AND CERTAIN DETAILS OF THE BONDS; AUTHORIZING THE CHAIRMAN OF COUNTY COUNCIL TO DETERMINE CERTAIN MATTERS RELATING TO THE BONDS; PROVIDING FOR THE PAYMENT OF THE BONDS AND THE DISPOSITION OF THE PROCEEDS THEREOF; AND OTHER MATTERS RELATING THERETO"

This is the Bond Ordinance being recommended to full Council by the Real Estate, Facilities & Land Management Committee for a County bond to be issued related to the construction of a new Anderson Oconee Behavioral Health Services [AOBHS] facility in Seneca; with all bond payments being made by AOBHS.

Sheriff Department / Acceptance of \$40,000 SCDNR Water Recreation Resources Funds

The SCDNR Water Recreational Resources Fund has granted funds to the Oconee County Sheriff's Office for the purchase of a boat for the Marine Unit. The patrol boat will be outfitted with the same equipment as the DNR Law Enforcement boats and will be utilized for protecting and patrolling Lake Hartwell, Lake Keowee and Lake Jocassee.

There is no match required for acceptance of these funds. The boat will be maintained with existing Sherriff's Department budgetary funds. There is an agreement presented for the receipt and expenditure of the funds pursuant to the SC Code Ann. 12-28-2730.

It is the staff's recommendation that Council [1] approve acceptance of \$40,000 from the SCDNR Water Recreational Resource Fund for the purchase of a patrol boat, and [2] authorize the County Administrator to execute the agreement.
