Oconee County Council met at 6:00 PM in Council Chambers, 415 South Pine Street, Walhalla, SC with all Council Members, Thomas L. Martin County Attorney, County Administrator Scott Moulder, Assistant Administrator Glenn Breed and Clerk to Council Elizabeth G. Hulse present.

## **Call to Order:**

Mr. Thrift called the meeting to order at 6:00 p.m.

Mr. Tom Markovich addressed Council in support of Ordinance 2012-32 but also voiced concerns regarding the overall building codes chapter of the Oconee County Code of Ordinances.

Mr. Brian Bayliss addressed Council reading from a proposal letter [copy filed with these minutes] regarding hydrogen.

Mr. Steve Sokol addressed Council regarding the proposed Fair Play Village plan.

Mr. B. J. Littleton addressed Council in opposition to the Fair Play Village plan and concerns regarding road damage related to the plan.

# **County Council Response to Public Comment:**

Ordinance 2012-32 "AN ORDINANCE TO AMEND SECTION 6-84, ENTITLED *VIOLATION AND PENALTIES* OF ARTICLE III, ENTITLED *ADMINISTRATION*, OF CHAPTER 6, ENTITLED *BUILDINGS AND BUILDING REGULATIONS*, OF THE OCONEE COUNTY CODE OF ORDINANCES, IN CERTAIN LIMITED REGARDS AND PARTICULARS ONLY, TO PROVIDE FOR ONLY CIVIL PENALTIES IN THE EVENT OF A VIOLATION OF THE BUILDING CODES AND REGULATIONS ADOPTED PURSUANT TO CHAPTER 6 OF THE OCONEE COUNTY CODE OF ORDINANCES; AND OTHER MATTERS RELATED THERETO"

## Sheriff / Approve Acceptance: FY12 Edward Byrne Memorial Justice Assistance Grant / \$21,479

Mr. Corbeil made a motion, seconded by Mr. McCall, approved 5-0 to accept the FY2012 Edward Byrne Memorial Justice Assistance Grant in the amount of \$21,479 with no local match required.
