Ms. Robyn Courtright, Procurement Director, and Mr. Moulder addressed Council regarding this request. Discussion followed.

Mr. McCall made a motion, seconded by Mr. Corbeil, approved 5 - 0 to award RFP 12-05 to Roebuck Buildings of Roebuck, SC, in a not to exceed amount of \$1,600,000.

Mr. Moulder and Mr. Corbeil, Capital Project Advisory Committee [CPAC] Chair, addressed several questions from Council regarding the CIP listing and the CPAC committee review process.

Mr. Corbeil made a motion, seconded by Mr. Barron, approved 5-0 to receive the CIP as presented and ask the Administrator to incorporate the list into the budget planning process for FY2014.

#### Oconee State Park / Request for Gravel Donation / up to \$3,000

Ms. JoAnn White, Oconee State Park Ranger, addressed Council regarding this request.

Mr. Dexter made a motion, seconded by Mr. McCall, approved 5 - 0 to approve a gravel donation to the Oconee State Park in an amount not to exceed \$3,000 to be paid from the Council Contingency Account.
