## **Discussion Regarding Action Items**

#### Recall from the Planning Commission with their recommendation Ordinance 2011-25

At the September 25, 2011 Council Meeting, first reading, in title only, of Ordinance 2011-25 "AN ORDINANCE TO AMEND THE OCONEE COUNTY ZONING ENABLING ORDINANCE, ORDINANCE 2007-18, IN CERTAIN LIMITED REGARDS AND PARTICULARS, ONLY, AS TO REZONE A SERIES OF PARCELS SPECIFIED HEREIN, AND TO RATIFY AND AFFIRM ALL OTHER PROVISIONS OF ORDINANCE 2007-18 NOT AMENDED OR MODIFIED HEREBY; AND OTHER MATTERS RELATING THERETO" [Council Initiated—Public & Recreational Lands] was heard at which time Council sent the ordinance to the Planning Commission for review and recommendation. The Commission heard the matter at their meeting on November 7, 2011. After receiving public comment, the Commission voted to recommend all parcels to be zoned into the Public and Recreational Lands District.

As stated in the Oconee County Code of Ordinances, 36-10-13; the intent of this zoning classification is to "provide for a continuation and identification of public lands and to allow for those uses typically associated with accomplishing the mission of the agency charges with the care and promotion of the land"

At the January 17, 2012 County Council meeting, second reading was held. Several parcels identified as being owned by the Oconee County Joint Regional Sewer Authority [OJRSA] were removed from the ordinance.

At the June 19, 2012 County Council meeting the public hearing was held with several citizens addressing Council regarding the ordinance. Based on public comment Council tabled action regarding this ordinance and sent the Ordinance to the Planning Commission for additional review, public input and recommendation to Council.

The request before Council is to [1] recall Ordinance 2011-25 from the Planning Commission with their recommendation, and [2] to take final action as the ordinance is in excess of one year old.
