## **Discussion Regarding Action Items**

#### Keowee Toxaway Relicensing / Stakeholder Agreement in Principal

Mr. Art Holbrooks, Strategic Planner & Special Projects, addressed Council utilizing a PowerPoint presentation and handouts [copies filed with these minutes] highlighting key aspects of the Agreement in Principal before council at this meeting.

Mr. Corbeil addressed Council and the public present reading from a prepared statement [copy filed with these minutes] in support for the process that led to the development of the Agreement in Principal as discussed.

Mr. McCall made a motion, seconded by Mr. Corbeil, approved 5 - 0 to authorize the Council Chairman to execute the Keowee-Toxaway Agreement in Principal rating letter; noting the rating as a number One.

#### **Keowee Falls Substation**

Mr. Moulder & Mr. Breed addressed Council utilizing a handout [copy filed with these minutes] regarding this revised request for construction of the Keowee Falls Fire Substation. Discussion followed.

Mr. Corbeil made a motion, seconded by Mr. Barron, approved 5 - 0 to revise the scope of work with road construction and other aspects of the project to be done in house by the county Road Department. \$155,376 is recommended to be awarded to contractor; \$26,534 allocated for in house work for a total project cost of \$181,910.

Mr. Moulder recommended at this time that Council make a motion to reiterate the award for this project to the selected contractor.

Mr. Corbeil made a motion, seconded by Mr. McCall, approved 5 - 0 to reiterate the award for the construction of the Keowee Falls Substation to Joel Davis as discussed at the June 4, 2013 meeting and to authorize the Administrator to execute the contract.

# **Council Committee Reports**

#### Law Enforcement, Public Safety, Health & Welfare Committee / Mr. McCall

Mr. McCall updated Council reading from a prepared statement [copy filed with these minutes] regarding discussions that took place regarding various topics at the June 10, 2013 meeting.

Mr. McCall made a motion, seconded by Mr. Thrift, approved 5 - 0 to approve the execution of the Mosquito Point Memorandum of Lease as presented.

Mr. McCall made a motion, seconded by Mr. Corbeil, approved 5 - 0 to encourage the County Delegation to move forward with a state wide distracting driving ban.

Mr. McCall made a motion, seconded by Mr. Corbeil, approved 5 - 0 to direct the Sheriff to work with the county attorney to draft an ordinance to be brought to Council for approval regarding the prohibition of the sale and/or ownership of drug paraphernalia and loitering.

# **Old Business**

#### Stone Pond Road Owners Association / \$207,585 / Engineering Study

Mr. Moulder and Mr. Breed addressed Council regarding this engineering study [copy of quote filed with these minutes]. Lengthy discussion followed.

Mr. McCall made a motion, seconded by Mr. Corbeil, approved 5 - 0 to approve the expenditure of a not to exceed amount of \$207,585 to Davis & Floyd for an engineering study for the Stone Pond subdivision roads; noting that tax revenues will reimburse this expense as received.

## New Business

### **Budget, Finance & Administration Committee**

Mr. Dexter announced that the **Budget, Finance & Administration Committee** meeting scheduled for August 13, 2013 has been canceled and rescheduled for Tuesday, July 23, 2013 at 6:00 p.m. in County Council Chambers.

## **Executive Session:**

Mr. Dexter made a motion, seconded by Mr. Corbeil, approved 5 - 0 enter into Executive Session for the purpose of receiving legal advice regarding a potential litigation matter and to discuss a contractual matter related to **Ordinance 2013-07**.

Council entered Executive Session at 7:46 p.m.

Council returned from Executive Session at 8:30 p.m. on a motion by Mr. Barron, seconded by Mr. McCall, approved 5 - 0. Mr. Thrift stated that no action was taken in Executive Session.

Mr. Corbeil made a motion, seconded by Mr. Dexter, approved 5 - 0 to authorize the County Administrator to proceed as discussed in Executive Session regarding the potential litigation matter.

Mr. Thrift made a motion, seconded by Mr. McCall, approved 5 - 0 to table action at this meeting regarding **Ordinance 2013-07** and schedule third reading for the July 16, 2013 Council meeting.

**Adjourn** Mr. McCall made a motion, approved unanimously 5 - 0, to adjourn at 8:33 p.m.
