This web-based tool increases the on-line visibility of Oconee County, providing innovative interactive analysis tools and delivering more current, complete, and easily-retrieved information. Companies and site location consultants considering the area will have greater access to more in-depth information, giving Oconee County a competitive advantage for economic development.
- Technical support, custom research, mapping and training to the Oconee County Economic Development Commission to support industrial recruitment efforts.
- Senior services benefits counseling. Provide information on resources available to seniors.
- Plan-A-Biz. This is an on-line decision support system for small businesses that provides critical marketing information.
- Regional Comprehensive Economic Development Strategy update. This ensures that projects in Oconee County remain eligible to receive federal Economic Development Administration and Appalachian Regional Commission grant funds.
- Board and commission training. ACOG provides a state mandated planning education program for board members and compliance staff for municipalities throughout the County.
- Staff training. ACOG provides supervisory and customer service training to employees from the County, municipalities across the County, and special purpose districts.
- Local government support. ACOG provides general governmental and planning assistance to Oconee County, as well as the municipalities of Salem, Seneca, Walhalla, Westminster, and West Union.
- Responded to 73 requests for information about Oconee County. These requests come from all over the world. Many are from firms considering investments in the County.

About ACOG

In the years since 1971, the Council has evolved into a multifaceted service organization for area local governments.

The Appalachian Council of Governments is a voluntary organization of local governments in Anderson, Cherokee, Greenville, Oconee, Pickens and Spartanburg Counties of Upstate South Carolina.

The organization began in 1965 as the Appalachian Advisory Commission, a 12-member board created to advise the Governor on the use of Appalachian Regional Commission funds.

Authorized by referendum, the Council of Governments system emerged in 1971. ACOG has become a valuable resource for area local governments in the areas of public administration, planning, information systems and technology, grants, workforce development and services to the elderly population. Encouraged and facilitated through the Council of Governments, this marriage of intergovernmental and private sector cooperation continues as a critical element in the region's economy and quality of life.

In 2013, approximately 76 percent of ACOG revenue came from federal funding. We encourage all the entities in our region to utilize this funding. Because of these federal dollars, we provide many services at no charge.

Policy, Management & Operations

A 44-member Board of Directors sets policy for the Council of Governments. Twothirds of the members are local elected officials, including state legislators, county council members, and mayors or city council members. County councils appoint the remaining citizen and minority members.

The Executive Director is responsible for the overall management of the Council of Governments. The director runs the day-to-day operations, and delegates specific responsibilities to department directors and staff.

Regionally, the Information, Referral and Assistance Specialist provided information and assistance to 6,445 seniors and caregivers.

ACOG's Area Agency on Aging

The S. C. Appalachian Council of Governments' Area Agency on Aging is designated by the Lt. Governor's Office on Aging as the coordinating and planning body for services for older persons in Anderson, Cherokee, Greenville, Oconee, Pickens, and Spartanburg Counties. The principal goal of the Area Agency is to develop and promote a comprehensive, coordinated community-based service delivery system with simple access that will improve the quality of life for all older adults in the region and enable them to lead independent lives with dignity in their own homes for as long as possible. Aging programs are funded by federal (79 %) and state (21 %) dollars. Programs include:

- Regional Long Term Care Ombudsman Program: complaint resolution for residents of long-term care facilities
- Family Caregiver Support Program
- I-CARE and Senior Medicare Fraud Prevention programs
- Senior Farmer's Market Program

The Aging Services Department welcomed a new director - Karen Carter - in May 2013.

A Glimpse Back at 2013

Ombudsman Program

The Ombudsman Program received 1,229 cases on behalf of long term care residents, resulting 990 investigations of abuse, neglect, exploitation and other issues.

Family Caregiver Support Program

Provided:

689 caregivers with in-home respite, supplies, information; referrat and assistance.

5.8 grandparents raising grandchildren or related kin with inhome respite, educational tutoring, clothes, shoes, & school supplies.

Medicare Guidance

- Certified Insurance Counselors provided on-site awareness, education and enrollment assistance to 6,000 Medicare beneficiaries and conducted outreach throughout the region.
- More than 524 applications were completed for the Medicare Savings Program, and over 500 applications were completed for extra help with the Medicare Drug Program.



Appalachian Development Corporation

The ADC is a non-profit economic development lending corporation offering multiple financing options that can be structured to meet your needs using our "gap-financing" loans. The ADC works in conjunction with local lending institutions to provide a structure that works by including long-term, fixed-rate, funding sources that lower the overall debt service requirements and allows for the maximum leverage of the applicant's resources. The funding comes primarily from public funds, thus the ADC's thrust is to create jobs for our area.

Among the ADC programs is the Appalachian Loan Fund (ALF). The ALF is a locally controlled source of low-cost, longterm; fixed-rate financing for businesses whose projects will result in the creation of permanent full time jobs and leverage private sector investment. More then \$2.1 million in ARC and IPP loans were closed in 2013,



thereby leveraging more than \$3.2 million in additional private capital

The ALF is a loan pool capitalized by grants from the Appalachian Regional Commission, the State of South Carolina, and from borrowings from the USDA.

Government Services

The Government Services Department works very closely with the towns, cities and counties in the six-county region of the Upstate, providing a variety of technical and professional support. The division serves as a one-stop resource for problem resolution and information by providing hands-on expertise, cost-effective consulting services and general Information.

The vast majority of funding for the Government Services Department comes from federal monies. An ARC grant provides staff with the necessary resources to give free services to our local governments. Please contact a staff member for additional information.

Examples of 2013 Services

 Provided various types of technical assistance to local governments in the six-county region. Technical support is available in the areas of paralegal research, finance and taxation, utility rate studies, information technology, community planning, sanitation, personnel, economic development, municipal court, organizational behavior, transportation, planning and other local government issues.

 Facilitated a live quarterly broadcast from the South Carolina Municipal Association to Upstate municipal officials on budgeting and financial issues for elected officials; The broadcast is hosted at ACOG facilities.

The mission of the Government Services Department is very simple: to help the governmental entities in this region in any way possible.

Grant Services

The primary function of the Grant Services Department is to assist local governments in identifying, securing, and administering funds for a wide range of community and economic development activities, including water and sewer facilities, road improvements, housing rehabilitation, community centers, and senior centers, downtown revitalization and streetscaping.

Services include application preparation and packaging, and aspects of grants all administration.

The Grant Services Department is funded by federal and local dollars. Most of the department's revenue is associated with grants

Investment Board

WorkLink Workforce Investment Corporation develops the link between employers and employees in Anderson. Oconee and Pickens Counties. The volunteer board of directors ensures that the local workforce development system is market-driven and responsible in meeting the employment and training needs of businesses and job seekers. The board implements the Workforce Investment Act of 1998 in partnership with local service providers and through a comprehensive workforce development system that provides access points for employment and training services.

ENVIRONMENTATION AND ADDRESS OF

WorkLink funds programs for adults, dislocated workers, and youth, and supports employers through on-the-job and incumbent worker training programs. In 2013, WorkLink also offered annual events such as the WorkLink Job Fair and the Business and Industry Showcase to connect companies and employees and to ensure that job seekers have the skills they need to find employment.

Planning & Economic Development

Planning and Information Services Merge in 2013 to become the Department of Planning and Economic Development!

The ACOG Planning and Information Services Department's have historically played important roles in regional economic development. While fulfilling separate but related tasks, each division has worked to create a regional environment that is conducive to economic growth and community development. While the role of the Planning Division has always been broad, - ranging from transportation and land use planning to regional sewer coordination - Planning has also supported regional economic development efforts through the region's annual *Comprehensive Economic Development Strategy* (CEDS), which identifies regional priorities for economic development, thus paving the way for federal and state grant projects. Information Services has played an equally important role in supporting economic development through its delivery of the national award-winning *InfoMentum* suite of GIS-based economic development services. Personnel from each division have worked hand-in-hand for many years with local, state, and federal economic developers on efforts to attract projects to the SC Appalachian Region.

In late 2013, these two closely aligned divisions were merged in order to create new efficiencies. Directing the broad range of services in this new Department of Planning and Economic Development (PLED) is the COG's long-time Planning Director, Chip Bentley. Reporting directly to Mr. Bentley is David Shellhorse, who will continue to execute economic development planning initiatives while he also takes on a new role of managing the InfoMentum program and staff. With the merger now in place, the Department of Planning and Economic Development will continue to work to improve the quality of life and economic conditions of the region. 1

2013 REGIONAL PLANNING INITIATIVES

Planning Education

Provided state required planning education to 171 staff, planning commission, and board of appeals members in communities throughout the region. We hosted 35 students in orientation classes and 136 students in continuing education classes during the course of the year at COG offices and in communities in the region.

Regional Transit Coordination Plan

Assisted local transit providers in the rural portions of the region in the transition to new federal requirements outlined in MAP 21 as part of continuing efforts to implement the Regional Transit Coordination Plan. Provided guidance to agencies as they worked to meet the Federal Transit Administration's requirements to receive transit funding. Also assisted with developing applications for projects and equipment for funding totaling over \$202,834 for the region.

Water Quality Management

Coordinated the Federal Clean Water Act Section 208 Water Quality Management Plan activities. COG staff reviewed **136** Section 208 compliance applications in 2013.

2013 REGIONAL ECONOMIC DEVELOPMENT INITIATIVES

Regional CEDS 2013 Progress Report


After completely re-writing the five-year regional *Comprehensive Economic Development Strategy* (CEDS) in 2012, a progress report of the CEDS was prepared for 2013. Maintaining the CEDS is an important function of ACOG by identifying the region's economic development priorities and assisting communities to be both eligible and competitive for federal grant funding. Guided by a steering committee with representation from our six counties plus the Upstate Alliance, the CEDS focuses on seven "areas of emphasis", which include (1) Clusters, Target Industries and Innovation Capacities, (2) Infrastructure, (3) Available Sites and Buildings, (4) Workforce Development, (5) Entrepreneurship, (6) Access to Capital, and (7) Local Asset-Based Economic Development. Major developments in the region are identified in this report, including construction of the transformative Inland Port in Greer and regional industry announcements totaling nearly \$646 million in capital investment and 2,067 new jobs.

Regional Entrepreneur Friendly Toolkit

PLED secured grant funding from the Appalachian Regional Commission to construct an on-line tool for increasing entrepreneurship and small business development in the region. Presently under development, the on-line "Entrepreneur Friendly Toolkit" will take communities through eight interactive planning steps that will help them organize around the goal of becoming more supportive of entrepreneurs. Completion of the steps will result in the ability to print a customized "Entrepreneur Friendly Action Plan" that contains specific local information. Special thanks to the City of Pickens and Oconee County for serving as the initial pilot communities during the development process.

Taking InfoMentum to the Next Level

PLED also secured grant funding from both the U.S. Economic Development Administration and the Duke Energy Foundation to complete two essential and exciting upgrades for the *InfoMentum* program: (1) the development of a Mobile App, and (2) the synchronization of *InfoMentum* with the South



in addition to spearheading development of the Regional Entrepreneur-Friendly Toolkit, PLED also worked with the ACOC Grints Department to help secure almost \$1.3 million in Federal grant funding for expansion of Spartenburg Community Callege's Center for Business & Entrepreneurial Development.

Carolina Department of Commerce LocateSC industrial marketing tool. Over the last 17 years, the InfoMentum suite of GIS-based economic development services has won several state and national awards for its ability to help economic developers win projects for the region. The grant dollars secured in 2013 will not only provide essential mobile technology capability, but also ensure that this region maintains the most cutting edge site selection tool in South Carolina.

 recruitment efforts; also worked with Tri-County Tech to develop an ARC application to upgrade and expand
 the weiding program in order to meet current industry needs, which received funding in the amount of
 \$250,000
- Worked with staff at the Anderson Office of Economic Development on a routine basis to provide customized
 research and mapping services in response to RFIs from industry prospects; assistance with prospect RFIs
 included: data compilation on local German population, manufacturing wages and labor force; detailed

STATE OF SOUTH CAROLINA OCONEE COUNTY ORDINANCE 2014-06

AN ORDINANCE TO DEVELOP A JOINTLY OWNED AND OPERATED INDUSTRIAL/BUSINESS PARK (SERENE HOSPITALITY, LLC) IN CONJUNCTION WITH PICKENS COUNTY, SUCH INDUSTRIAL/BUSINESS PARK TO BE GEOGRAPHICALLY LOCATED IN OCONEE COUNTY AND ESTABLISHED PURSUANT TO SOUTH CAROLINA CODE OF LAWS OF 1976 §4-1-170, ET SEQUITUR, AS AMENDED; TO PROVIDE FOR A WRITTEN AGREEMENT WITH PICKENS COUNTY PROVIDING FOR THE EXPENSES OF THE PARK, THE PERCENTAGE OF REVENUE APPLICATION, AND THE DISTRIBUTION OF FEES IN LIEU OF AD VALOREM TAXES TO THE COUNTIES AND RELEVANT TAXING ENTITIES: TO PROVIDE THAT JOB TAX CREDITS ALLOWED BY LAW BE PROVIDED FOR BUSINESSES LOCATING IN SAID PARK; TO PERMIT A USER FEE IN LIEU OF AD VALOREM TAXATION WITHIN SAID PARK; AND TO AUTHORIZE THE EXECUTION AND DELIVERY OF AN INTERGOVERNMENTAL AGREEMENT WITH THE CITY OF SENECA RELATED TO THE CREATION OF THE PARK WITHIN THE CITY LIMITS OF THE CITY OF SENECA AND THE DISTRIBUTION OF CERTAIN FEES IN LIEU OF AD VALOREM TAXES DUE TO OCONEE COUNTY FROM THE PARK. AND THE PAYMENT BY OCONEE COUNTY TO THE CITY OF SENECA OF AN ECONOMIC DEVELOPMENT GRANT, SOLELY FOR THE USE OF THE CITY OF SENECA FOR SERENE HOSPITALITY, LLC; AND TO **AUTHORIZE** THE **EXECUTION** AND DELIVERY OF AN INFRASTRUCTURE FINANCING AGREEMENT BETWEEN OCONEE COUNTY AND SERENE HOSPITALITY, LLC; AND OTHER MATTERS RELATED THERETO, INCLUDING, WITHOUT LIMITATION, THE AUTHORIZATION OF AN INFRASTRUCTURE TAX CREDIT IN FAVOR OF SERENE HOSPITALITY, LLC.

WHEREAS, Oconee County, South Carolina (the "County"), acting by and through its County Council (the "County Council") is authorized and empowered under and pursuant to the provisions of the Code of Laws of the State of South Carolina, 1976, as amended (the "Code"), including, without limitation, Titles 4 and 12, including, particularly, Chapter 44 of Title 12 of the Code (collectively, the "Act"), to offer and provide certain privileges, benefits, and incentives to prospective developers as inducements for economic development within the County; to acquire, or cause to be acquired, properties (which such properties constitute "projects" as defined in the Act) and to enter into agreements with any business to construct, operate, maintain and improve such projects; to enter into or allow financing agreements with respect to such projects; and, to accept any grants for such projects through which powers the industrial and business development of the State of South Carolina will be promoted and trade developed by inducing manufacturing and commercial enterprises to locate and remain in the State of South Carolina and thus utilize and employ the manpower, agricultural products and natural resources of the State and benefit the general public welfare of the County by providing services, employment, recreation, tourism or other public benefits not otherwise provided locally; and

WHEREAS, the County is authorized by Article VIII, Section 13 of the South Carolina Constitution and Section 4-1-170 of the Code (the "Joint-County Industrial and Business Park Act"), to enter into agreements ("Park Agreements") with one or more contiguous counties for the creation and operation of one or more joint-county industrial and business parks; and

WHEREAS, Serene Hospitality, LLC (the "Company"), a limited liability company, duly authorized to do business in South Carolina, and, in fact, already doing business in the State, has acquired by construction or purchase or lease/purchase certain land and buildings, and by construction or purchase certain furnishings, fixtures, machinery, apparati, and equipment, for the development of a hotel facility in the County (the "Project"), which will result in an expected total investment of Nine Million Dollars (\$9,000,000) in the County, which would be subject to this Agreement, all within the meaning of the Act, and the creation of new, full-time jobs in the County, during the period beginning with the first day that real or personal property comprising the Project was purchased or acquired and ending five (5) years after the last day of the Company's property tax year during which the Project is placed in service (the "Initial Investment Period"); and

WHEREAS, the County has determined that the Project, and recruitment of the Company to Oconee County and the City of Seneca (the "City"), would be aided by the availability of the assistance which the County and City might render through (1) the inclusion and retention of the Project and the other real and personal property of the Company located at the Project site in the County, in a joint-county industrial and business park which is either already in existence, or to be created by the County (the "Park" or the "Joint-County Park"), with the consent of the City; (2) the granting by the County to the Company of certain infrastructure credits, pursuant to Section 4-1-175 of the Code and other applicable provisions of the Act (the "Infrastructure Credits"), to partially reimburse the Company for economic development infrastructure serving the County; (3) the provision of an infrastructure grant to the City to aid in providing infrastructure for the Project; and, that the inducement will, to a great degree of certainty, result in the acquisition and construction of the Project in the County; and

WHEREAS, the County has given due consideration to the economic development impact of the Project, has found that the Project and the Park payments-in-lieu-of-taxes from the Project in the Park would be directly and substantially beneficial to the County, the taxing entities of the County, and the citizens and residents of the County, and that the Project would directly and indirectly benefit the general public welfare and serve a public purpose of the County by providing services, employment, recreation, promotion of tourism, or other public benefits not otherwise provided locally; and, that the Project gives rise to no pecuniary liability of the County, or a charge or pledge against the full faith, general credit. or taxing power of the County; and, that the purposes to be accomplished by the Project, i.e., economic development and welfare, creation of jobs, promotion of tourism, and addition to the manufacturing footprint and tax base of the County, are proper governmental and public purposes and that the inducement of the location or expansion of the Project within the County and State is of paramount importance and that the benefits of the Project will be greater than the cost; and, has agreed to effect the issuance, execution and delivery of an Infrastructure Financing Agreement, an Intergovernmental Agreement with the City, and a Park Agreement, pursuant to this Ordinance of the County Council, and on the terms and conditions set forth therein; and

WHEREAS, the County has previously enacted its ordinance 2012-17, on September 17, 2013, which authorized the infrastructure credits referred to herein; and

WHEREAS, the Project has now been completed, and County Council desires to make the terms of the incentives offered to the Company fit the actual investment by the Company, and otherwise to approve and ratify the incentives with the Company; ratify and approve the terms and provisions of an intergovernmental agreement and infrastructure grant with the City; approve, ratify, and affirm all acts and actions of the County previously undertaken in furtherance of the Project and as described herein; and authorize the execution and delivery of the documents described herein; and

WHEREAS, Pickens County and Oconee County, South Carolina (jointly the "Counties") are authorized under Article VIII, Section 13 of the South Carolina Constitution to jointly develop the Park within the geographical boundaries of one or more of the member counties; and

WHEREAS, in order to promote the economic welfare of the citizens of the Counties by providing employment and other benefits to the citizens of the Counties and promoting economic development in, and enhancing the tax base of the County, and the City, the County proposes to enter into an agreement with Pickens County, with the consent of the City, by Intergovernmental Agreement to develop jointly the Park (Serene Hospitality, LLC) wholly within Oconee County and the City as provided by Article VIII, Section 13 of the South Carolina Constitution and in accordance with Section 4-1-170 of the Code of Laws of South Carolina, 1976, as amended, (the "Act"), and to authorize the Park Agreement, the Intergovernmental Agreement, and the Infrastructure Financing Agreement.

NOW, THEREFORE, BE IT ORDAINED BY THE OCONEE COUNTY COUNCIL:

Oconee County is hereby authorized to execute and deliver a written Section 1. agreement to jointly develop an industrial and business park (the "Park") with Pickens County, with the approval of any municipality within which the Park property shall lie. The Park is to be located within the boundaries of Oconee County. The form, terms, and provisions of the joint county industrial and business park agreement (the "Agreement") presented to this meeting and filed with the Clerk of the Oconee County Council be and they are hereby approved and all of the terms, provisions and conditions thereof are hereby incorporated herein by reference as if the Agreement were set out in this Ordinance in its entirety. The Chairman of County Council and the County Administrator be and they are hereby authorized, empowered and directed to execute, acknowledge and deliver the Agreement in the name and on behalf of the County. The Agreement is to be in substantially the form now before this meeting and hereby approved, or with such changes therein as shall not be materially adverse to the County and as shall be approved by the officials of the County executing the same, their execution thereof to constitute conclusive evidence of their approval of any and all changes or revisions therein from the form of Agreement now before this meeting. Because all or a portion of the Park property is or shall be located within the municipal limits of the City of Seneca, the City of Seneca must consent, and chooses to consent, to creation of this Park. An Intergovernmental Agreement has been created through which, among other things,

as discussed further herein, the City of Seneca consents to creation of the Park within its municipal limits, in return for the County's agreement to distribute to the City of Seneca the City's proportionate share (based on the City's proportionate share of the millage from which Park fees in lieu of taxes are calculated in the year of taxation) of the Oconee County portion of the fee in lieu of tax revenues from the Park, after payment of the 1% partner county fee to Pickens County from the overall Oconee County revenues from the Park, and after payment of any special source revenue credit or bond authorized from such revenues. The County is hereby authorized to execute and deliver the Intergovernmental Agreement with the City of Seneca. The Park is to be located within the boundaries of Oconee County and the City. The form, terms, and provisions of the Intergovernmental Agreement (the "Intergovernmental Agreement") presented to this meeting and filed with the Clerk of the Oconee County Council be and they are hereby approved and all of the terms, provisions and conditions thereof are hereby incorporated herein by reference as if the Intergovernmental Agreement were set out in this Ordinance in its entirety. The Chairman of County Council and the County Administrator be and they are hereby authorized, empowered and directed to execute, acknowledge and deliver the Intergovernmental Agreement in the name and on behalf of the County. The Intergovernmental Agreement is to be in substantially the form now before this meeting and hereby approved, or with such changes therein as shall not be materially adverse to the County and as shall be approved by the officials of the County executing the same, their execution thereof to constitute conclusive evidence of their approval of any and all changes or revisions therein from the form of Intergovernmental Agreement now before this meeting.

<u>Section 2.</u> The maximum tax credits allowable by South Carolina Code of Laws of 1976, Section 12-6-3360, as amended, will apply to any business enterprise locating in the Park.

<u>Section 3.</u> Any business or industrial enterprise locating in the Park shall pay a fee-inlieu of *ad valorem* taxes as provided for in the Agreement, Article VIII Section 13 of the South Carolina Constitution and the Act. The user fee paid in lieu of *ad valorem* taxes shall be paid to the Oconee County Treasurer. That portion of the fees from the Park premises located in Oconee County and allocated pursuant to the Agreement to Pickens County shall be paid by the Oconee County Treasurer to the Pickens County Treasurer within thirty (30) business days following the end of the calendar quarter of receipt for distribution, in accordance with the Agreement. Payments of user fees shall be made by a business or industrial enterprise on or before the due date for taxes for a particular year. Penalties for late payment will be at the same rate and at the same times as for late tax payment. Any late payment beyond said date will accrue interest at the rate of statutory judgment interest. The Counties, acting by and through the county tax collector for Oconee County, shall maintain all liens and rights to foreclose upon liens provided for counties in the collection of *ad valorem* taxes.

<u>Section 4.</u> The administration, development, promotion, and operation of the Park shall be the responsibility of Oconee County. Provided, that to the extent any Park premises is owned by a private developer or entity, the developer or entity shall be responsible for development expenses as contained in the Agreement.

Section 5. In order to avoid any conflict of laws or ordinances between the Counties, Oconee County ordinances and the ordinances of the City of Seneca (once the Serene Hospitality, LLC Project is annexed into the City) will be the reference for such regulations or laws in connection with the Park. Nothing herein shall be taken to supersede any state or federal law or regulation.

<u>Section 6.</u> Law enforcement agencies for Oconee County and the City of Seneca (once the Serene Hospitality, LLC Project is annexed into the City) will have initial jurisdiction to make arrests and exercise all authority and power within the boundaries of the Park. Water, sewer and fire services will be provided by the entities which provide such services for the geographic location of the Park in Oconee County or the City of Seneca. EMS service will be provided by Oconee County or the City of Seneca, or both.

<u>Section 7.</u> The Intergovernmental Agreement shall also address, ratify, and affirm an economic development grant (the "Grant") made by the County to the City, to pay for a portion of the infrastructure necessary to induce Serene Hospitality, LLC to locate and build in the City and County, and to support the construction and operation of the Serene Hospitality, LLC Project, and to support the continued economic development of the City and County. Oconee County Council hereby finds and declares that economic development of the City and County is a public purpose, that the Grant will be used for economic development of the City and County, that the Grant will be used for a public purpose and, to the extent used for public infrastructure, for public use, that the Grant and the city funds to induce the construction and operation of the City and County, thus adding to the tax base of both, and creating additional employment in both, all of which are public purposes of economic development. Council hereby approves and ratifies the Grant, as set forth in greater detail in the Intergovernmental Agreement.

Section 8. Oconee County hereby designates that the distribution of the fee-in-lieu of ad valorem taxes pursuant to the Agreement and the Intergovernmental Agreement with the City of Seneca, received and retained by Oconee County for Park premises shall be as directed by Oconee County Council, including, without limitation, by and through its annual budget ordinance and the Agreement and the Intergovernmental Agreement with the City of Seneca, provided that the County may, from time to time, by ordinance, amend the distribution of the fee-in-lieu of tax payments to all taxing entities, except as otherwise regulated by law or agreement. All taxing entities levying ad valorem taxes or property located within the Park shall receive some distribution of ad valorem taxes, after distribution of the payment of the partner county fee and payment for any special source revenue bonds or credits, as provided herein and in the Intergovernmental Agreement. Zero percent (0%) of the fee-in-lieu-of-tax payments from the Park shall be paid to any taxing entity, other than those designated by Oconee County Council, herein, or in the Agreement or in the Intergovernmental Agreement, or otherwise. A portion of the fee-in-lieu of ad valorem taxes which Oconee County and/or the City of Seneca receives and retains pursuant to the Agreement for Park premises may be, from time to time and by ordinance of Oconee County Council, or Seneca City Council, or their successors, respectively, designated for the payment of special source revenue bonds or applied as a credit ("Special Source Revenue Credit, or SSRC") against qualifying infrastructure as provided for in Title 4, Chapters 1, 12 or 29, and Title 12, Chapter 44 of the South Carolina Code of Laws, 1976, as amended. Specifically, but without limitation, Oconee County authorizes and directs that an SSRC of up to Seven Hundred Thousand Dollars (\$700,000) be made available to the Company from payments made by the Company for the Project in the Park, all as set forth more fully in the Infrastructure Financing Agreement ("IFA") attached hereto and hereby incorporated herein by reference as fully as if set forth verbatim herein. The IFA is to be in

substantially the form attached hereto or with such changes therein as shall not be adverse to the County and as shall be approved by the officials of the County executing the same, their execution thereof to constitute conclusive evidence of their approval of any and all changes or revisions therein from the form of Intergovernmental Agreement now before this meeting. Nothing contained herein, however, shall alter the distribution pursuant to the Intergovernmental Agreement, except as and unless mutually agreed upon in writing by Oconee County and the City of Seneca.

<u>Section 9.</u> Should any section of this Ordinance be, for any reason, held void or invalid, it shall not affect the validity of any other section hereof which is not itself void or invalid.

<u>Section 10.</u> The Agreement may not be terminated except by concurrent ordinances of Pickens County Council and Oconee County Council, in accordance with the terms of the Agreement.

STATE OF SOUTH CAROLINA OCONEE COUNTY ORDINANCE 2014-07

AN ORDINANCE TO ESTABLISH THE OFFENSE, EXCEPTIONS, DEFINITIONS, AND PENALTIES OF DISTRACTED DRIVING IN OCONEE COUNTY; AND OTHER MATTERS RELATED THERETO

WHEREAS, Oconee County Council (the "County Council") has reviewed or received reports on national data indicating that texting and the use of cell phones, smart phones, and similar hand held devices create undue distractions for persons operating cars, trucks, and other vehicles on streets and highways; and

WHEREAS, such studies are reliably and clearly presented in the website of the United States Government at DISTRACTION.GOV and those findings are incorporated herein by reference; and

WHEREAS, County Council nonetheless recognizes that itemizing all types of distracted driving in Oconee County, South Carolina (the "County"), a body politic and corporate and a political subdivision of the State of South Carolina (the "State"), is not feasible and crafting an understandable ordinance to address all conceivable situations would undermine the opportunity to promote safe driving by addressing a substantial portion of those situations as provided here; and

WHEREAS, County Council finds it is in the best interest of the citizens and residents of Oconee County, and visitors to Oconee County to take action to improve the safety of our highways by permitting the use of mobile phones and other mobile communication devices by drivers of a moving vehicle only when such devices are used in a "hands free" device configuration, except as specifically authorized, herein; and

WHEREAS, County Council finds it necessary for the benefit of the citizens and residents of Oconee County, and visitors to Oconee County, and Oconee County law enforcement to clearly identify which activities are prohibited and which activities are permitted with regard to operating a vehicle while using a mobile hand held communication device; and

WHEREAS, County Council finds the clearest, most understandable, and most reasonably enforceable method of addressing the growing issue of drivers distracted by the use of mobile communication devices is to provide a bright line standard of permitting drivers of a moving vehicle to use mobile communication devices in a hands free mode only, with a very limited number of specific exceptions, only; and

WHEREAS, County Council finds operators of motor vehicles, motorcycles, mopeds, and bicycles, all while moving, who use mobile communication devices all pose similar dangers to the County's citizens, residents, and visitors;

NOW, THEREFORE, the following ordinance pertaining to distracted driving in Oconee County, South Carolina, is hereby ordained by Oconee County Council in lawful meeting duly assembled:

Distracted Driving

(a) *Offense*: No person shall operate a moving motor vehicle, motorcycle, moped, or bicycle on, or in, a public street, public highway, public parking lot, or public parking garage in the unincorporated portion of Oconee County while using a mobile phone or other portable electronic communication device.

(b) *Exceptions*: The provisions of subsection (a), above, shall not apply to the following:

(1) The operator of a motor vehicle, motorcycle, moped, or bicycle that is legally parked at the time.

(2) The operator of a motor vehicle, motorcycle, moped, or bicycle who is using a mobile phone or other portable electronic communication device that is specifically designed and configured to allow hands free use and is being used in that manner at the time.

(3) The operator of a motor vehicle, motorcycle, moped, or bicycle using a mobile phone or other portable electronic communication device specifically to report a crime or emergency situation to the appropriate authorities.

(4) The operator of a motor vehicle, motorcycle, moped, or bicycle which is legally stopped or stationary in traffic. For example, a driver at a traffic control device waiting for a signal change may use said device without being "hands free", but only while the vehicle is completely stationary.

(5) A law enforcement officer, firefighter, emergency medical services personnel, ambulance driver, or other similarly employed public safety personnel using a mobile phone or portable electronic communication device solely for emergency purposes in the performance of his or her official duties.

(c) Definitions:

(1) *Bicycle* shall be given its plain and ordinary meaning of a two wheeled, human propelled conveyance. Bicycle shall include said human propelled conveyances with any number of wheels, including but not limited to three wheelers.

(2) Mobile phone means a mobile, wireless telephone.

(3) *Motor vehicle* is defined by Title 56, Chapter 1, Article 1, §56-1-10(7) of the South Carolina Code of Laws.

(4) *Motorcycle and moped* shall be defined by Title 56, Chapter 1, Article 1, §56-1-10(8) of the South Carolina Code of Laws.

(5) Operate means to drive a motor vehicle, motorcycle, moped, or bicycle.

(6) Other portable electronic communication device means a mobile phone, cellphone, text-messaging device, personal digital assistant, computer, tablet, or any other substantially similar wireless device that is used to initiate or receive a wireless communication or data. Other portable electronic communication device does not mean a direct connect, two-way, push button activated, voice radio.

(7) Using a mobile phone or other portable electronic communication device means talking into, listening to a communication on, sending text messages with, reading text messages on the screen of, sending e-mail with, reading e-mail on the screen of, or viewing the screen of said device.

(a) A person who holds a mobile phone or other portable electronic communication device up to, or proximately near, his or her ear is presumed to be

using it to talk into or listen to a communication on said device in violation of this section.

(b) A person who holds a mobile phone or other portable electronic communication device while manipulating the keyboard or screen is presumed to be using it to read or send text messages, read or send e-mails, or view the screen of said device in violation of this section.

(d) **Penalties:**

(1) A violation of this Ordinance shall be punishable by a fine of:

(a) up to \$100 plus court costs for a first offense;

(b) up to \$200 plus court costs for a second offense occurring within one year of first offense; and

(c) up to \$300 plus court costs for a third or subsequent offense occurring within one year of a second offense.

(e) Should any part or provision of this Ordinance be deemed unconstitutional or unenforceable by any court of competent jurisdiction, such determination shall not affect the rest and remainder of this Ordinance, all of which is hereby deemed separable.

(f) All ordinances, orders, resolutions, and actions of Oconee County Council inconsistent herewith are, to the extent of such inconsistency only, hereby repealed, revoked, and rescinded.

(g) This Ordinance shall take effect and be in full force and effect from and after third reading and enactment by Oconee County Council.

STATE OF SOUTH CAROLINA OCONEE COUNTY ORDINANCE 2014 -08

AN ORDINANCE CALLING FOR A REFERENDUM TO **AUTHORIZE THE SOUTH CAROLINA DEPARTMENT OF REVENUE TO ISSUE TEMPORARY PERMITS TO** FOR THE POSSESSION. SALE, AND **ALLOW** CONSUMPTION OF ALCOHOLIC LIQUORS BY THE DRINK TO BONA FIDE NONPROFIT ORGANIZATIONS AND BUSINESS ESTABLISHMENTS AUTHORIZED TO **BE LICENSED FOR CONSUMPTION-ON-PREMISES** SALES AND TO ALLOW THE SALE OF BEER AND WINE AT PERMITTED OFF-PREMISES LOCATIONS WITHOUT **REGARD TO THE DAYS OR HOURS OF SALE; AND OTHER MATTERS RELATED THERETO.**

WHEREAS, Oconee County, South Carolina (the "County"), a body politic and corporate and a political subdivision of the State of South Carolina (the "State"), acting by and through its governing body, the Oconee County Council (the "County Council"), has previously adopted multiple ordinances for the effective, efficient governance of the County, which, subsequent to adoption, are codified in the Oconee County Code of Ordinances (the "County Code"), as amended, from time to time; and,

WHEREAS, certain business and nonprofit organizations within the County desire to have the ability to possess, sell, and offer for consumption alcoholic liquors by the drink on-premises and to sell beer and wine at permitted off-premises locations seven days a week, with no limitation on the days or hours upon which such beer and wine can be sold; and,

WHEREAS, pursuant to Section 61-6-2010(C)(4) of the Code of Laws of South Carolina, 1976, as amended (the "Code"), entitled *Temporary permits upon referendum vote*, a county or municipal governing body is authorized by ordinance to call for a referendum to be conducted at the next general election on the issue of allowing the issuance of a temporary permit to certain business and nonprofit organizations within the County to possess, sell, and offer for consumption alcoholic liquors by the drink on-premises and to sell beer and wine at permitted off-premises locations seven days a week, with no limitation on the days or hours upon which such beer and wine can be sold; and,

WHEREAS, pursuant to Section 61-6-2010(C)(4) of the Code, the County Council seeks to call for a referendum and have the Oconee County Election Commission conduct the referendum and place a question on the ballot at the next general election to be held on November 4, 2014 to determine if the qualified electors shall allow for the issuance of a temporary permit to certain business and nonprofit organizations within the County to possess, sell, and offer for consumption alcoholic liquors by the drink on-premises and to sell beer and wine at permitted off-premises locations seven days a week, with no limitation on the days or hours upon which such beer and wine can be sold:

NOW, THEREFORE, it is hereby ordained by the Oconee County Council, in meeting duly assembled that:

- 1. The statements of fact and policy from the preamble of this Ordinance are hereby adopted, as findings of fact, by the County Council, in their entirety, and are hereby adopted by reference, as part of the ordaining language of this Ordinance as fully as if set forth verbatim herein. It is the specific intent of the County Council to enact an ordinance that is fully authorized by the law and Constitution of the State, and is consistent with and does not violate State law.
- 2. Pursuant to the authority granted in Section 61-6-2010(C)(1)(b) of the Code, the County Council hereby requests that the Oconee County Election Commission place the following question, attached hereto as <u>Exhibit A</u>, which is hereby incorporated herein as fully as if set forth verbatim herein, on the ballot at the next general election to be held on November 4, 2014, and to cause a notice to be published in the newspaper of general circulation at least seven (7) days before the referendum. The deadline to submit the referendum question to the Oconee County Election Commission is noon on Friday August 15, 2014.
- 3. The County Administrator is hereby authorized and directed to take any and all actions required of the County, or that he may deem desirable in his sole discretion, to give effect to the acts of the County Council as contemplated herein.
- 4. Should any part or provision of this Ordinance he deemed unconstitutional or unenforceable by any court of competent jurisdiction, such determination shall not affect the rest and remainder of this Ordinance, all of which is hereby deemed separable.
- 5. All ordinances, orders, resolutions, and actions of the County Council inconsistent herewith are, to the extent of such inconsistency only, hereby repealed, revoked, and rescinded. However, nothing contained herein, or in <u>Exhibit A</u> hereto, shall cancel, void, or revoke, or shall be interpreted as cancelling, voiding, or revoking in any regard any prior County acts, actions, or decisions of the County or the County Council, in any regard, except as explicitly and specifically stated herein.
- All other terms, provisions, and parts of the County Code not amended hereby, directly or by implication, shall remain in full force and effect.
- This Ordinance shall take effect and be in full force and effect from and after the third reading and the public hearing and enactment by the County Council in accordance with the County Code.




