Mr. Corbeil made a motion, seconded by Mr. Dexter, approved 4 - 0, to approve **Ordinance 2014-03** on first reading in title only.

Ordinance 2014-14: [in title only] AN ORDINANCE TO IMPOSE A ONE PERCENT CAPITAL PROJECT SALES TAX, SUBJECT TO A REFERENDUM, WITHIN OCONEE COUNTY, SOUTH CAROLINA, PURSUANT TO THE CAPITAL PROJECT SALES TAX ACT, AS CODIFIED IN §4-10-300, ET SEO., OF THE SOUTH CAROLINA CODE OF LAWS, 1976, AS AMENDED (THE "ACT"); TO SPECIFY THE PURPOSES, PROJECTS AND FACILITIES FOR WHICH THE PROCEEDS OF SUCH TAX MAY BE USED; TO PROVIDE THE MAXIMUM TIME FOR WHICH SUCH TAX MAY BE IMPOSED; TO PROVIDE THE MAXIMUM AMOUNT OF GENERAL OBLIGATION BONDS TO BE ISSUED TO PROVIDE FOR THE PAYMENT OF ANY COSTS OF THE PROJECTS AND FACILITIES AND TO PLEDGE SUCH TAX TO THE PAYMENT OF THE BONDS; TO PROVIDE THE MAXIMUM COST OF THE PROJECTS OR FACILITIES TO BE FUNDED FROM THE PROCEEDS OF SUCH TAX OR BONDS: TO PROVIDE THE MAXIMUM AMOUNT OF NET PROCEEDS OF THE TAX EXPECTED TO BE USED TO PAY THE COST OF THE PROJECTS OR DEBT SERVICE ON THE BONDS: TO ORDER A REFERENDUM PRESCRIBED BY THE ACT TO BE CONDUCTED BYTHE OCONEE COUNTY REGISTRATION AND **ELECTIONS** COMMISSION; TO PROVIDE FOR THE ADMINISTRATION OF SUCH TAX; AND OTHER MATTERS RELATING THERETO.

Mr. Dexter made a motion, seconded by Mr. Corbeil, approved 4 - 0, to approve **Ordinance 2014-14** on first reading in title only.

Prior to the May 6, regular meeting, Council members individually ranked the proposed Capital Sales Tax Projects, anonymously, for the purpose of discussion. Mr. Stephens provided a summary sheet detailing the anonymous ranking [copy is filed with these minutes, labeled as initial summary sheet].

Discussion followed regarding establishing a prioritized project list of the approved Capital Sales Tax Projects.

Mr. McCall stated he had misunderstood the scoring procedures and that his thoughts on the matter were not accurately represented in the initial summary sheet.

Mr. Thrift called for a recess of 10 minutes, at 6:38, to allow for Mr. McCall to rank the proposed Capital Sales Tax Projects. Mr. Thrift reconvened the meeting at 6:48.

Mr. Moulder and Mr. Stephens incorporated the new data into the summary sheet [copy is filed with these minutes, labeled updated summary sheet] and provided the updated summary sheet.

Upon review of the update summary sheet, two ties in ranking were present:

- Tied for second place Northern Economic Development & Indoor Recreation/Aquatic Center
- Tied for eighth place Library System Enhancement/Salem Branch & Library System Enhancement/Walhalla Branch

Further discussion followed regarding the ties in ranking in regards to establishing a prioritized project list.

Mr. Corbeil made a motion, seconded by Mr. McCall, approved 4- 0, to establish the Northern Economic Development project as the number 2 (second) project and the Indoor Recreation/Aquatic Center and the number 3 (third) project on the prioritized project list.

Mr. Corbeil made a motion, seconded by Mr. Dexter, approved 4-0, to establish the Library System Enhancement/Salem Branch Project as the number 8 (eighth) project and the Library System Enhancement/Walhalla Branch as the number 9 (ninth) project on the prioritized project list.

Mr. Dexter made a motion, seconded by Mr. Corbeil, approved 4 - 0, to approve the Capital Project Sales Tax Prioritized List as modified [copy filed with these minutes, labeled as approved and accepted Capital Project Sales Tax Prioritized List].

Discussion Regarding Action Items:

ITB 13-13 Tellabs Equipment for Broadband, \$250,000.00

Mr. McCall motioned, seconded by Mr. Corbeil, approved 4-0, to (1) approve the award of ITB 13-13 for Tellabs Equipment to Core Telecom Systems, Inc., of St. Louis, MO, not to exceed \$250,000.00 in a one year period and (2) authorize the County Administrator to approve the renewal of this award, not to exceed four (1) one year renewals.

Coroner/Sheriff's Substation Building \$315,342.30.

Mr. McCall motioned, seconded by Mr. Corbeil, approved 4-0, to approve the award of \$ 315,342.30 (includes \$15,016.30 owner contingency) to Roebuck Buildings, Co., Inc., of Roebuck, SC to construct the Coroner/Substation building.
