Mr. Thrift called the meeting to order at 6:05 p.m.

Sheriff Mike Crenshaw addressed Council is opposition to the proposed cuts to the sheriff's FY 2014-2015 budget before Council for second reading.

Mr. Moulder outlined the communities request to maintain **Barton's Mill Landing in the Army Corp of Engineer's [ACOE] lease**. He recommended that Council add this landing with the proviso that the community continue to maintain the landing as they have for many years and if they choose to no longer maintain the ramp note that the county will abandon the boat landing at that time. Discussion followed.

Mr. Dexter made a motion, seconded by Mr. Corbeil, approved 4-0 to add Barton's Mill Landing to the ACOE lease contingent upon the community continuing to maintain the landing as discussed above.
